THE QUEEN has been pleased by Letters Patent under the Great Seal of the Realm, bearing date the 9th day of February 1978, to confer the dignity of a Barony of the United Kingdom for life upon Oliver Ross McGregor, Esquire, by the name, style and title of BARON McGREG-OR OF DURRIS, of Hampstead in Greater London.

#### Present,

The QUEEN'S Most Excellent Majesty in Council

Whereas a Representation duly made to Her Majesty in Council by the Secretary of State for the Environment that burials should be discontinued as hereinafter directed in St. Lawrence's Churchyard and St. Lawrence's Old Churchyard, Fingringhoe Road, East Donyland, Rowhedge, in the County of Essex, has, in pursuance of an Order in Council made the 11th day of October 1977, and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853 (1853 c. 134), and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1. Burials shall be discontinued forthwith in St. Lawrence's Churchyard and St. Lawrence's Old Churchyard, Fingringhoe Road, East Donyland, Rowhedge, in the County of Essex, shown hatched on the plans annexed hereto.

#### Provided that-

- (a) In any earthen grave now existing in the Churchyard surrounding St. Lawrence's Church, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
- (b) In St. Lawrence's Old Churchyard, Fingringhoe Road, in the two grave spaces in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
- 2. This Order may be cited as the Burial Grounds (St. Lawrence's Churchyard and St. Lawrence's Old Churchyard, East Donyland, Rowhedge, Essex) Order 1978.
