Appropriating the redundant parish church of the former parish of Rishangles, in the diocese of Saint Edmundsbury and Ipswich and parts of the land annexed thereto for use for residential purposes and for purposes ancillary thereto and empowering the said Commissioners to sell the said building and land for such uses.
- 8. Appropriating a detached burial ground in the parish of Kingsclere, in the diocese of Winchester, to use as a public burial ground, vesting the said land in the Winchester Diocesan Board of Finance and empowering the said Branch to give the said land for such use.
- 9. (1) Dissolving the benefice of Saint Peter, Warrington, in the diocese of Liverpool; (2) declaring redundant the parish church of the parish of Saint Peter, Warrington; and (3) altering the areas of the parishes of Saint Peter Warrington, Saint Ann, Warrington; and Warrington.
- 10. Uniting the benefices and parishes of Saint Mary with Saint Peter, Oldham; Saint Andrew, Oldham; and Coldhurst, in the diocese of Manchester, and establishing a team ministry for the area of the new benefice.
- 11. Appropriating the redundant remains of the church of Saint Mary in Arden in the parish of Market Harborough in the diocese of Leicester, all the land annexed or belonging thereto, to use as a monument and to purposes ancillary thereto, and empowering the said Commissioners to give the said building and land for such uses.
- 12. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant parish church of the parish of Basildon, and the land annexed or belonging thereto, in the diocese of Oxford.
- 13. (1) Transferring the parish of Newington from the benefice of Cheriton with Newington to the benefice of All Souls, Cheriton-street; (2) altering the names of the benefices of Cheriton with Newington; and All Souls, Cheriton-street; (3) transferring the patronage of the benefice of All Souls, Cheriton-street; and (4) altering the areas of the parishes of All Souls, Cheriton-street; Cheriton; Holy Trinity with Christ Church, Folkestone; Newington; and Sandgate, in the diocese of Canterbury.
- 14. (1) Uniting the benefices of North Hill; Altarnon and Bolventor; and Lewannick, in the diocese of Truro; (2) uniting the parishes of Altarnon and Bolventor; and (3) establishing a team ministry for the area of the new benefice.
- 15. Declaring redundant the church of Saint Andrew, Netteswell, a chapel of ease in the parish of Tye Green with Saint Andrew, Netteswell, in the diocese of Chelmsford.
- 16. (1) Dissolving the benefices of Ocle Pychard with Felton, Preston Wynne and Ullingswick; Stoke Lacy with Nuch Cowarne and Moreton Jeffries; and Bodenham with Hope under Dinmone; (2) creating new benefices of Stoke Lacy with Much Cowarne, Moreton Jeffries, Ocle Pychard and Ullingswick; and Bodenham with Hope-under-Dinmore, Felton and Preston Wynne; and (3) uniting the parishes of Felton and Preston Wynne, in the diocese of Hereford.
- 17. Altering the areas of the parishes of Saint Andrew, Minley; and Hawley, in the diocese of Guildford, and the parish of Yateley, in the diocese of Winchester.
- 18. Uniting the benefices of Trull and Angersleigh, in the diocese of Bath and Wells.
- 19. Uniting the benefices of Stratton Saint Margaret; and South Marston with Stanton Fitzwarren in the diocese of Bristol, establishing a team ministry for the area of the new benefice and constituting a patronage board for it.
- 20. Creating the new benefice and parish of Saint David, Carr Mill, from part of the parish of Saint Mark, Saint Helens, in the diocese of Liverpool.
- 21. Transferring the house and premises known as Liddon House, South Audley Street, London, being glebe of the benefice of Saint George, Hanover Square with Saint Mark, in the diocese of London, to the London Diocesan Fund for use as a residence.
- 22. Uniting the benefices of Wedmore with Theale; and Blackford, in the diocese of Bath and Wells.

- to use as a shrine or monument or for Christian community purposes and empowering the Norwich Diocesan Board of Finance to lease the building for such uses.
- 24. (1) Uniting the benefices of Saint Saviour, Harome; Stonegrave with Nunnington; and Pockley-cum-East Moors, in the diocese of York; (2) altering the name of the parish of Pockley-cum-East Moors; and (3) altering the areas of the parishes of Pockley-cum-East Moors; Helmsley; and Nunnington.
- 25. (1) Providing for a new place of worship within the parish of Saint Luke Deeplish, Rochdale, in the diocese of Manchester; (2) declaring redundant the existing parish church of the said parish; and (3) authorising the demolition of the existing parish church and empowering the Church Commissioners to sell its site and the land annexed or belonging thereto.
- 26. (1) Providing for a new place of worship within the parish of Saint Barnabas, Knowle, in the diocese of Bristol; (2) declaring redundant the existing parish church of the said parish; (3) authorising the demolition of the nave of the said church and appropriating the remainder of the said church, and part of the land annexed or belonging thereto to use by the parochial church council for any ecclesiastical purpose; and (4) empowering the said Commissioners to sell or lease the site of the nave and part of the said land.
- 27. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of Elston Old Chapel, a former chapel of ease in the parish of Elston, in the diocese of Southwell, and the land annexed or belonging thereto.
- 28. Declaring redundant the church of Saint Mary, Winslade in the parish of Herriard with Winslade, in the diocese of Winchester.
- 29. Uniting the benefices of Eyke with Bromeswell and Rendlesham with Wantisden; and Tunstall with Dunningworth, and altering the name of the parish of Tunstall with Dunningworth, in the diocese of Saint Edmundsbury and Ipswich.
- 30. Uniting the benefices of Berrow with Pendock; and Eldersfield, in the diocese of Worcester.
- 31. Uniting the benefices and parishes of Saint John with Saint Simon, Bethnal Green; and Saint Bartholomew, Bethnal Green, in the diocese of London; (2) establishing a team ministry for the area of the new benefice; and (3) declaring redundant the parish church of the parish of Saint Bartholomew, Bethnal Green.
- 32. (1) Declaring redundant the Church of Saint Margaret, Southolt, a chapel of ease in the parish of Bedingfield with Southolt; (2) transferring a turn of the patronage of the benefice of Worlingworth with Tannington; (3) altering the areas and changing of names of the parishes of Bedingfield with Southolt; and Worlingworth; (4) altering the names of the benefices of Bedingfield with Southolt; and Worlingworth with Tannington; and (5) uniting the benefices of Bedingfield and Thorndon with Rishangles, in the diocese of Saint Edmundsbury and Ipswich.
- 33. Uniting the benefices of Norton-sub-Hamdon with Chiselborough; and uniting the benefices of Middle with West Chinnock, in the diocese of Bath and Wells.
- 34. Uniting the benefices of Alfrick with Lulsley and Suckley; and Leigh with Bransford; and uniting the parishes of Alfrick with Lulsley; and Leigh with Bransford, in the diocese of Worcester.
