#### NOTICE OF PUBLIC PATH ORDER

*The London Borough of Bexley Footpath No. 125  
Public Path Diversion Order 1976 No. 1*

Notice is hereby given pursuant to paragraph 2 (3) of the Seventh Schedule to the Highways Act 1959 that the Secretary of State for the Environment proposes to modify the London Borough of Bexley Footpath No. 125 Public Path Diversion Order 1976 No. 1, by providing an alternative line for the diversion proposed by the Order starting from the footbridge crossing the River Cray at the south-eastern corner of Hall Place Nurseries, marked "A" on the map hereinafter referred to, and running in a north-easterly direction for a distance of approximately 17 yards to a point marked "J" on the map, then in a south-easterly direction for a distance of approximately 288 yards within the recreation ground, along the eastern side of the fence/ beech hedge forming the eastern boundary of Hall Place Gardens, to a point marked "K" on the map, then in a south-westerly direction for a distance of approximately 111 yards to the railway bridge running under the A.2, marked "G" on the map, and then in a westerly direction up concrete steps to the A.2 trunk road at a point marked "H" on the map. The proposed alternative path will be approximately 6 feet wide between points "A" and "G"
