The effect of the order, if confirmed without modification, will be to divert a length of public footpath AA5 over land to the south-west of Boddington Road, Aston-le-Walls, from a point in Butler's sociangton Road, Aston-le-Walls, from a point in Butler's Close at grid reference 49665103 and running in a westerly direction for a distance of 108 metres to a point at grid reference 49555103 at its termination at the classified road to a line running from the said point at grid reference 49665103 for a distance of 140 metres in a southerly, westerly and porth, westerly direction along the accuracy to 4965103 for a distance of 140 metres in a southerly, westerly and north-westerly direction along the pavement to the cul-de-sac in the new residential development to a point approximately 22 metres from the head of the cul-de-sac and then in a westerly direction to a point on the classified road at grid reference 49555102 approximately 5 metres to the north of the said point at grid reference 49555103.

South Pembrokeshire District Council Conservation Areas

Notice is hereby given that the South Pembrokeshire District Council has resolved to designate the following part of the South Pembrokeshire District as a Conservation Area.

The whole of the Old Town virtually in its entirety. The boundary from Hill House which is included, runs east across Northfield Road to include No. 2 Northfield Road to No. 6 Spring Gardens, then south to the west side of the footpath known as The Drang, excluding the Auction Rooms and Narberth A.F.C. Clubhouse then eastwards to include both sides of St. James Street to the Kirkland Arms Hotel and Nos. 20 James Street to the Kirkland Arms Hotel and Nos. 20 and 21 Station Road, then at the rear of the east side of the properties facing St. James Street southwest to the Flat in Tabernacle Lane and to the rear of No. 5 and the Sunday School. Then south following the stream to the east of the Castle then west to include the cemetery and St. Andrews Church and Parcel No. 7844 and Outbuildings of Plas Farm, then following the rear of properties of Water Street and High Street and the Cemetery of Bethesda Chapel then to the rear of Oueens Hall but excluding the garages to the rear of Queens Hall but excluding the garages on the Town Moor then across the Moorfield Road to Hill House, and all that area included within the above boundary.

(c) buildings specified in a direction by the Secretary of State and

and requires that any building to which section 277A applies shall not be demolished without the consent of the Council

shall not be definished without the consent of the Council or of the Secretary of State.

Section 61A of the Town and Country Planning Act 1971 applies to all trees within Conservation Areas other than trees included in Tree Preservation Orders and prohibits the cutting down, lopping, topping, uprooting, wilful damage or wilful destruction of trees, except where a tree is dangerous.
