## WAGES COUNCIL

### EMPLOYMENT PROTECTION ACT, 1975

#### *Flax and Hemp Wages Council (Great Britain)*

The Flax and Hemp Wages Council (Great Britain) hereby gives notice of proposals for amending the provisions relating to holiday remuneration set out in the Wages (Flax and Hemp) (Holidays) Order 1977 (Order FH(148)).

The Wages Council intends that the revised provisions shall come into operation on 6th April 1978.
