Carroways Place, Union Row and Addington Street, Margate Extension of "No Waiting" Restriction

Notice is hereby given that the Thanet District Council, in exercise of powers delegated to it by the Kent County Council, the highway authority, made an Order on 9th February 1978 under sections I (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974. It will come into operation on 17th February 1978.

The effect of this Order is that you are not allowed.

The effect of this Order is that you are not allowed, except upon the direction or with the permission of a police constable in uniform, to cause or permit your vehicle to wait in the length of road or on either of the sides of road specified in the Schedule to this notice between the hours of 8 a.m. and midnight on any day. (N.B. This is in addition to the "no waiting" restriction currently in

force in the area.)

Exceptions will permit the following:

(1) waiting for so long as may be necessary:

(a) for persons to board or alight;

(b) for enabling works to be carried out;

(c) in pursuance of statutory powers or duties; and
 (d) for the loading or unloading of goods; and

(2) the waiting of disabled persons' vehicles.

A copy of the Order and a map showing the length and sides of road concerned may be inspected, during normal office hours, at:

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended as aforesaid, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 9th February 1978, apply to the High Court for this purpose.

Notice is hereby given that the Tunbridge Wells Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972, with the County Council of Kent have made an Order operative from 1st March 1978 under sections 35, 36, 37 and 39 of the Road Traffic Regulation Act 1967, as amended, by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, to provide for the following: provide for the following:

- 1. To continue to provide for a further period of one year from 1st March 1978 the on-street parking place for residents of Calverley Street, Tunbridge Wells, operative 24 hours a day, in that section of the north-west side of Calverley Street between a point 17 metres north-east of its junction with Garden Street and a point 17.5 metres south-west of its junction with Grover Street.
- 2. At the present time, there is an annual charge of £10 per permit and a half-yearly charge of £5. The new Order referred to above will provide for an annual charge of £8 per permit and half-yearly charge of £4.
- 3. It will be an offence for any vehicle not displaying a permit to wait in the above parking place but invalid carriages and disabled persons vehicles are allowed to wait in the parking place free of charge.
- 4. Also, exceptions will permit waiting for the purpose

(a) Picking up and setting down passengers.

(b) The use of vehicles for Fire Brigade or Ambulance purposes or in the service of a Local Authority or of a Police Force in the pursuance of statutory powers or duties.

(c) The use of vehicles in connection with the removal

of furniture.

(d) The use of vehicles for the purpose of delivering or collecting goods or merchandise.
(e) The use of Post Office Corporation vehicles for

delivering and collecting postal packets.
