Wolverhampton Borough Council Stopping-Up of Part of Colliery Road, Wolverhampton

HIGHWAYS ACT 1959

Woodspring District Council (Footpath No. AX 14/16) No. H.5 Public Path Diversion Order 1977

Notice is hereby given that on 1st February 1978, the Woodspring District Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert a section of footpath AX 14/16 situate at Grange Farm, Churchill in the County of Avon for a distance of about 207 metres which said section runs in a straight line in a north-east-south-west direction between points A and F coloured brown on the plan annexed to the Order to a zig-zag line running along the hedgerows between points A-B-C-D-E-F in a generally north to south to east to west then in a south-south-west to south-south-east direction for a distance of 284 metres and shown coloured purple, thus connecting footpath AX 14/14 with AX 14/16.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at the offices of the Planning Department of the Woodspring District Council, Woodborough Road, Winscombe, Avon and at the Clerk's Department, Town Hall, Weston-super-Mare, Avon between the hours of 8.45 a.m. and 1 p.m. and 2 p.m. and 4.30 p.m. on Mondays to Fridays inclusive.

The Order becomes operative as from 17th February 1978, but if any person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of

Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 17th February 1978, make an application for the purpose to the High Court.

The Greater London (Parking Places) Consolidation (Amendment No.) Order 197

The Richmond Upon Thames (Waiting and Loading Restriction) (Amendment No.) Order 197

Notice is hereby given that the Greater London Council propose to make the above-mentioned Orders under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The effect of the Greater London (Parking Places) Consolidation (Amendment No.) Order 197 would be to revoke the designation by the Greater London (Parking Places) Consolidation Order 1977 of all the street parking places in Kew Green.

3. The general effect of the Richmond upon Thames (Waiting and Loading Restriction) (Amendment No.) Order 197 would be further to amend the Richmond upon Thames (Waiting and Loading Restriction) Order 1976, so that in the lengths of Kew Green specified in the Schedule to this notice and in the first 18.29 metres of adjacent Priory Road:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited between 8.30 a.m. and 8.30 p.m. on Saturdays, Sundays and Bank Holidays between 1st April and 30th September inclusive in any year;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be prohibited between 11 a.m. and 6.30 p.m. on Saturdays, Sundays and Bank Holidays between 1st April and 30th September inclusive in any year;
- (c) the sale or offer for sale of goods from a vehicle would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Richmond upon Thames Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, would be prohibited.
