### TYNE AND WEAR COUNTY COUNCIL

2. When the Orders come into effect the existing Metered Parking and Residents Parking Zones will be enlarged. The area to be extended will be bounded by the north side of Edward Street, the east side of Egremont Place, the east side of Queen's Park Road, the south side of Albion Hill, Richmond Gardens, Richmond Place and Grand Parade.

The proposed Orders will be as follows:

- (a) Two hour parking meters, charging 10p for two hours parking will be provided in the streets shown in the First Schedule to this Notice;
- (b) Four hour parking metres, charging 20p for four hours parking, will be provided in the streets shown in the Second Schedule to this Notice;
- (c) Free Parking Bays in which parking will be permitted without any charge or time limit, will be provided in the streets shown in the Third Schedule to this Notice;
- (d) Residents Parking Bays in this area which will be called "Area H", will be provided in the streets shown in the Fourth Schedule to this Notice;
- (e) Motor Cycle Parking Bays will be provided in the streets shown in the Fifth Schedule to this Notice;
- (f) Disabled Drivers Parking Bays which are at present in John Street and Kingswood Street will be retained in their present positions;
- (g) The prohibition of waiting at any time and the restriction of waiting, which exist at present on the streets in the area, will be, in some instances amended. Waiting will also be prohibited at all times at all road junctions and also on parts of other streets within this new area. All streets within the area, except where there are parking bays, will have a no waiting ban from 9 a.m. to 6 p.m. on Mondays to Saturdays inclusive. The streets or parts of streets having a prohibition of waiting at all times ban are shown in the Sixth Schedule to this Notice;
- (h) Waiting will be prohibited between 8 a.m. to 6 p.m. on Mondays to Saturdays inclusive in Albion Street, west side, from a point 70 feet north of the northern kerb line of Richmond Street to its junction with the prolongation of the southern kerb line of Albion Hill.

Exceptions to 2 (g) and 2 (h) will permit waiting for the purposes of:
