(v) to provide new means of access to premises; all on or in the vicinity of the route of the above-mentioned part of the said Motorway; and

(b) provide for the transfer of each of the said new highways to Surrey County Council as from the date on which he notifies that authority that the new highway has been completed and is open for through traffic.

(a) to improve, raise, lower, or otherwise alter, Chapel Street, Stade Street, Footpath No. 54, Bank Street, Mount Street, Marine Walk Street, Theatre Street, Sun Lane, Douglas Avenue, Station Road, the access road between the ioinery works and "Dunromin";
