Proposed Traffic Regulation Order

City of Coventry (Various Roads) (Prohibition and Restriction of Waiting) No. 1 Order 1978

Notice is hereby given that, pursuant to the powers delegated to them by the West Midlands County Council under section 101 of the Local Government Act 1972, Coventry City Council propose to make the above-mentioned Order under section 1 of the Road Traffic Regulation Act 1967, as amended.

This Order seeks to:

(a) Impose prohibitions or restrictions of waiting on certain lengths of the undermentioned roads and/or to consolidate therein certain existing prohibitions or restrictions of waiting in various lengths of these roads:

Bulls Head Lane Brandon Road

Coombe Street Humber Road Tennyson Road Willenhall Lane Winifred Avenue.

Exemptions will be provided for boarding or alighting; loading or unloading; emergency vehicles; local authority vehicles on statutory duties; vehicles engaged on building operations or demolitions in or adjacent to the lengths of road concerned, on the removal of obstructions to traffic, on the maintenance of the roads, sewers, telegraphs or of the on the maintenance of the roads, sewers, telegraphs or of the supply of gas, water or electricity; for funeral corteges; for the delivery or collection of postal packets or where a vehicle is required by law to stop, obliged to do so to avoid an accident or prevented from proceeding by circumstances outside the control of the driver and for vehicles used by disabled persons.

Please Note:

In respect of the majority of the above-mentioned roads the proposed prohibitions or restrictions of waiting only relate to small sections of the roads. Anyone who is interested in any of these proposals is therefore urged to obtain further information by inspecting the relevant plans at any of the locations detailed below.

(b) Revoke the existing prohibition of waiting in Mile Lane from its junction with Ringway St. Patricks/ Quinton Road Roundabout for a distance of 79 feet south-east of that junction.

Copies of this draft Order and relevant plans giving full details may be inspected and any further information obtained at the Council House (Room 11) during normal

Any objection to any of these proposals must be sent in writing to me quoting reference CS11/DCA/CJS by the 17th March 1978.

Any person who wishes to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act on the grounds that any requirement of that section or of section 84A, 84B or 84C of the Act or any regulations made under the said section 84C has not been complied with may, within 6 weeks from the date on which the Order was made, make application to the High Court for that purpose.
