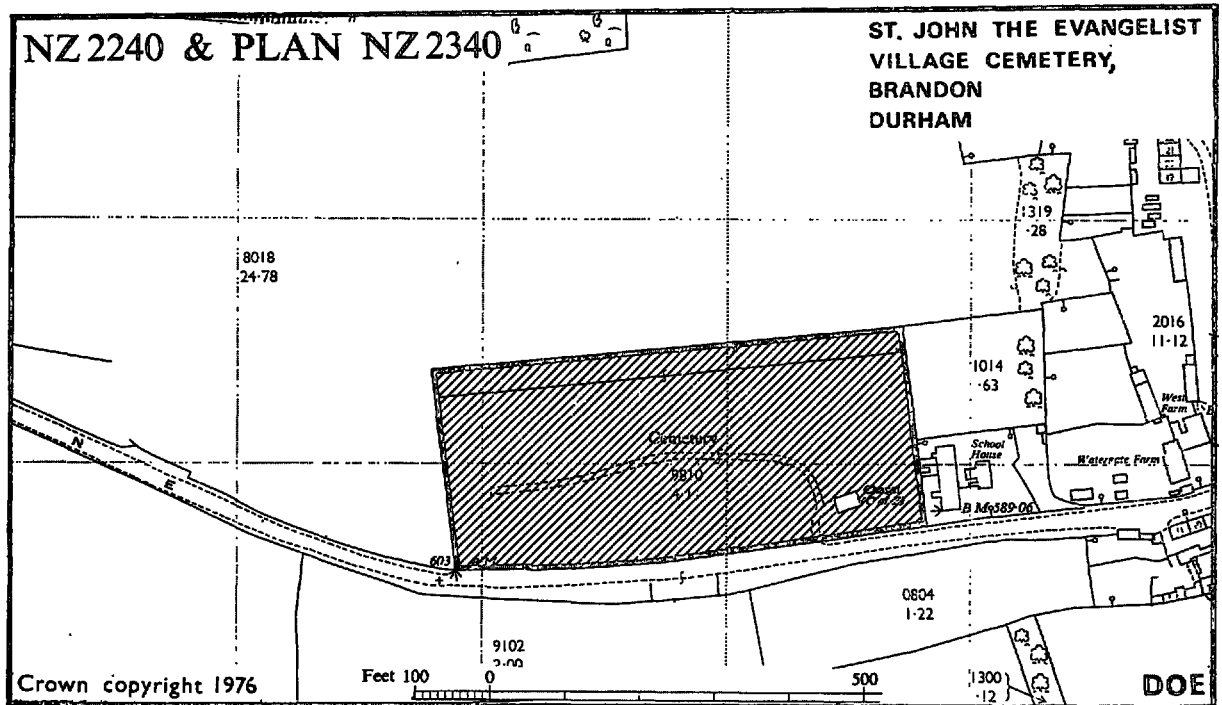


The Plan referred to in the foregoing Order in Council

In the matter of VASTOBERG LIMITED and in the matter of the Companies Act, 1948

Notice is hereby given that by an order made on Tuesday, the 17th day of January 1978 upon the petition of the above named Vastoberg Limited (hereinafter called the company) and John Patrick O'Donnell a member of the company on the 14th December 1977 preferred unto this Court

And upon hearing the solicitors for the petitioners and for the Registrar of Companies (the respondent)

And upon reading the said petition the affidavit of John Patrick O'Donnell filed the 14th day of December 1977 and the exhibits in the said affidavit referred to

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition

And the petitioners by their solicitors undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by section 124 and 126 of the Companies Act 1948 a copy of the annual return of the company for the year 1977 and to send to the Registrar of Companies as required by section 200 of the Companies Act 1948 as originally enacted a return in the prescribed form containing the particulars in the register of directors and secretaries of the company specified in section 200(2) of the Companies Act 1948 and a notification in the prescribed form of any change among the directors of the company or in its secretary and in the particulars contained in its register of directors and secretaries and of the date on which each such change occurred and to give to the Registrar of Companies as required by section 107 of the Companies Act 1948 notice of the situation of the registered office of the company at the date of its incorporation and notice in the prescribed form of any change in such situation since that date

And the petitioner John Patrick O'Donnell by his solicitor undertaking within one month of the restoration of the name of the company to the register of companies to deliver to the Registrar of Companies as required by sections 1 and 6 of the Companies Act 1976 a copy of every docu-

ment required by the said section 1 to be comprised in the accounts of the company

This Court doth order that the name of the above named Vastoberg Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the Companies Act 1948 the said Vastoberg Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this order in his official name in the *London Gazette*

And it is ordered that the petitioners the said Vastoberg Limited and John Patrick O'Donnell do jointly and severally pay to the Registrar of Companies his costs of the said petition such costs to be on the High Court Scale and to be taxed on the Common Fund basis if not agreed.
