The County of Dyfed (Cwmisfael Road, Llanddarog) (40 m.p.h. Speed Limit) Order 1978

Notice is hereby given that on the 22nd February 1978, the Dyfed County Council made an Order under section 74 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to impose a 40 m.p.h. speed limit in the length of road specified in the Schedule to this notice.

The Order will come into operation on the 1st March 1978, and a copy of the Order, together with a map indicating the length of road affected, may be inspected at the offices of the Dyfed County Council, County Hall, Carmarthen, during the usual office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.

The County of South Glamorgan (Caeglas Road, Rumney, Cardiff) (Prohibition of Waiting) Order 1978

Notice is hereby given that on the 23rd February 1978, the County Council of South Glamorgan in exercise of its powers under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended, made an Order, the general effect of which is to prevent you from causing or permitting any vehicle to wait between the hours of 8 a.m. and 6 p.m., on any day other than a Sunday on the east side of Caeglas Road, Rumney, Cardiff, from its junction with Llanstephan Road to its junction with Cricieth Road.

SOUTH GLAMORGAN COUNTY COUNCIL

The County Council of South Glamorgan (York Street, Cardiff) (Experimental Prohibition of Waiting) Order 1978
