## WIRRAL BOROUGH COUNCIL

*Wirral Borough Council**Traffic Regulation Orders*

Notice is hereby given that on 13th February 1978, Wirral Borough Council, with the consent of the Secretary of State for Transport and pursuant to arrangements made under section 101 of the Local Government Act, 1972 with the County Council of Merseyside in exercise of the powers of the said County Council, made the undermentioned Orders under sections 1 (1), (2), (3) and (6) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974:

1. *Metropolitan Borough of Wirral (Claughton Road, Birkenhead) (Restriction of Entry Except for Buses) Order 1978.*

The effect of this Order will be to prohibit any vehicle other than a stage carriage, to enter Claughton Road from a point 17 metres east of the east side of its junction with the service road at the rear of the premises on the east side of Milton Pavement to the west side of its junction with the service road at the rear of the premises on the west side of Princes Pavement.

Exceptions will be provided in the Order to permit:

- (a) the maintenance of roads;
- (b) the supply of gas, electricity and water;
- (c) the pursuance of statutory powers and duties; and
- (d) emergencies, if the vehicle is being used by the police, fire brigade or ambulance services.

2. *Metropolitan Borough of Wirral (Claughton Road, Birkenhead) (Prohibition of Driving) Order 1978*

The effect of this Order will be to prohibit any vehicle other than a stage carriage, to enter Claughton Road from the west side of its junction with the service road at the rear of the premises on the western side of Princes Pavement to the west side of its junction with Conway Street.

Exceptions will be provided in the above Order to permit:

- (a) the delivery and collection of goods in Claughton Road and in the service roads at the rear of the premises on the western side of Princes Pavement, the northern side of Borough Pavement and the eastern side of Milton Pavement;
- (b) the maintenance of roads;
- (c) the supply of gas, electricity and water;
- (d) the pursuance of statutory powers and duties; and
- (e) emergencies, if the vehicle is being used by the police, fire brigade or ambulance services.

The Orders will come into operation on 12th March 1978 and copies thereof and map may be seen at all reasonable hours at the Department of Administration and Legal Services (Room 22), Town Hall, Wallasey.

If you wish to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers conferred by the Act of 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Orders, you may within 6 weeks from 13th February 1978, apply to the High Court for this purpose.

*Wirral Borough Council Box Junctions (No. 1) Order 1977*

Notice is hereby given that on 13th February 1978, Wirral Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Merseyside, made the above Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order will be to prohibit the driving of a vehicle into a boxed area marked on the carriageway at the junctions specified in the Schedule to this Notice, unless the way is clear for such vehicle to proceed immediately out of the boxed area.

An exception will be provided in the Order relating to vehicles being used by the police, fire brigade or ambulance services.

The Order will come into operation on 12th March 1978 and a copy thereof and map may be seen at all reasonable hours at the Department of Administration and Legal Services (Room 22), Town Hall, Wallasey.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Act of 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 13th February 1978, apply to the High Court for this purpose.

## TRAFFIC REGULATION ORDERS

Notice is hereby given that on 13th February 1978, Wirral Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Merseyside, made the under-mentioned Orders under sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974:

1. *Metropolitan Borough of Wirral (Kendal Street and Claughton Road, Birkenhead) (Prohibition of Driving) Order 1977.*

The effect of the above Order will be to prohibit any vehicle to enter or leave Kendal Street at its junction with Claughton Road.

2. *Metropolitan Borough of Wirral (Service Road at the rear of the Premises on the Eastern Side of Milton Pavement and Claughton Road, Birkenhead) (Prescribed Route) Order 1977.*

The effect of the above Order will be that every person driving in a northerly direction in the service road at the rear of the premises on the eastern side of Milton Pavement shall cause the vehicle on reaching the junction of the aforesaid service road with Claughton Road, to make a left-hand turn into Claughton Road.

3. *Metropolitan Borough of Wirral (Salisbury Street and Various Streets, Birkenhead) (One-Way Traffic) Order 1977.*

The effect of the above Order will be to prohibit any vehicle to travel along the length of road specified in the first column of the Schedule to this notice other than in a direction specified in the second column of the Schedule.

The Orders will come into operation on 12th March 1978 and copies thereof and maps may be seen at all reasonable hours at the Department of Administration and Legal Services (Room 22), Town Hall, Wallasey.

If you wish to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers conferred by the Act of 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Orders, you may, within
