

Stephenson Close, both sides and end. In front of entrance to garages and of parking areas only.

Southampton Place, south side, from junction with western Service Road to Princes Road for a distance of 15 metres westwards.

St. Peter's Road, south side, from 50 metres west of Wellington Road to 70 metres west of Wellington Road.

Marine Parade South, west side, from pedestrian crossing near Wellington Pier for a distance of 75 metres northward.

South Quay, access to Library, south side of access road, across access to Library car park.

Standard Place, west side, from junction with St. Peter's Road for 20 metres northwards.

Suffolk Place, south side, from Nelson Road Central to Union Road.

Swanston's Road, both sides, from 15 metres east of junction with Admiralty Road to 15 metres west of Admiralty Road.

Nelson Place, west side, from junction with St. Nicholas Road for a distance of 20 metres northwards.

Tar Works Road, north side, from junction with Lawn Avenue for a distance of 75 metres westwards.

Tottenham Street, south side, from Nelson Road North to Factory Road.

Great Yarmouth—South of the River

Avondale Road, both sides, from 15 metres east of Bells Road junction to 15 metres west of Bells Road.

Baker Street, south side, from 1 metre east of Library vehicle entrance to 1 metre west of Library vehicle entrance.

Back Pier Plain

West side, from south boundary of bakery entrance to north boundary of bakery entrance.

East side, from Englands Lane to Pier Plain.

Bells Road

East side, from junction with Englands Lane for a distance of 15 metres southwards.

East side, from junction with Avondale Road for a distance of 15 metres northwards.

Both sides, from junction with Avondale Road for 15 metres southwards.

Both sides, from junction with Clarence Road for 15 metres northwards.

Bells Marsh Road (cul-de-sac adjacent to No. 78), both sides, from junction with Bells Marsh Road, for entire length of cul-de-sac.

Boundary Road, both sides, from 75 metres east of Suffolk Road to 75 metres west of Suffolk Road.

Brasenose Avenue, west side, extent of lay-by in front of Nos. 144, 146 and 148.

Clarence Road, both sides, from 15 metres east of Bells Road to 15 metres west of Bells Road.

High Street, east side, from opposite junction with Palmer Road, for a distance of 20 metres southward.

Marsh Road, north-west side, from junction with Mill Road for a distance of 15 metres south-westwards.

Suffolk Road, both sides, from 75 metres north of Boundary Road to 75 metres south of Boundary Road.

The Order comes into operation on the 26th February 1978.
