PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 1st March 1978 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Saint Thomas, Blackburn; and Saint Jude, Blackburn in the diocese of Blackburn.
2. (1) Substituting the church of Saint Saviour, Hatherton, a chapel of ease within the parish of Christ Church, Gailey-cum-Hatherton, as the parish church of that parish; (2) declaring redundant the existing parish church of that parish; (3) altering the name of the benefice and parish of

Christ Church, Gailey-cum-Hatherton; and (4) altering the areas of the parishes of Christ Church, Gailey-cum-Hatherton and Penkridge, in the diocese of Lichfield.

3. Uniting the benefices of Chelmondiston with Harkstead; and Shotley with Erwarton, in the diocese of Saint Edmundsbury and Ipswich.

4. Uniting the benefices of Long Whatton and Diseworth, in the diocese of Leicester.

5. Vesting a further part of the churchyard of the parish church of the parish of Holy Trinity, Leverstock Green in the diocese of Saint Albans, in the Saint Albans Diocesan Board of Finance.

6. (1) Uniting the benefices of Saint Thomas, Colnbrook; Datchet; Dorney; and Wyrardisbury (otherwise known as Wraysbury); (2) establishing a team ministry for the area of the new benefice, and (3) dissolving the benefices of Horton; and Eton with Eton Wick and Boveney, and transferring the parishes of Horton, and Eton with Eton Wick and Boveney to the new benefice, in the diocese of Oxford.

7. Uniting the benefices of Moreton and Church Eaton, in the diocese of Lichfield.

8. Altering the areas of the parishes of Saint Nicholas, Durham; and Saint Giles, Durham, and incorporating in those parishes the extra-parochial place known as Porters Close and part of the extra-parochial place known as Saint Magdelene, Durham, in the diocese of Durham.

9. Providing for the demolition of the redundant parish church of the former parish of Etruria, in the diocese of Lichfield, and empowering the said Commissioners to sell or lease its site and the land annexed or belonging thereto.

10. (1) Revoking parts of a previous Scheme which provided for the demolition of the redundant church of Clay Coton, in the diocese of Peterborough; (2) appropriating the said church with the exception of the roof of the nave which is to be demolished to use as a monument and for purposes ancillary thereto, and (3) empowering the said Commissioners to give the redundant building for such uses.

11. (1) Revoking a previous Scheme which provided for the demolition of the redundant church of East Burton, a former chapel of ease in the parish of Wool with East Burton in the diocese of Salisbury; (2) appropriating the said church to use as a workshop for the assembly and decoration of harpsichords and for purposes ancillary thereto and (3) empowering the said Commissioners to sell the said church for such uses.
