#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

Pursuant to Section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely a Matra-Simca motor vehicle registration number KW 759B, imported into the United Kingdom by Abdul Rahim have been seized as liable to forfeiture upon the grounds that 1. Relief from payment of the duty chargeable was afforded under the provisions of the Customs Duty (Personal Reliefs) Order 1970 (as amended made under Section 7 of the Finance Act 1968 and subsequently the Commissioners were not satisfied that a certain condition imposed by Article 6 (1) thereof had been complied with, namely, that the said goods would not be, or be offered, exposed or advertised to be, lent, hired, pledged, given away, exchanged, sold, or otherwise disposed of in the United Kingdom, subject to which such relief had been afforded. 2. The said goods, being relieved from Customs Duty, on condition that they would not be, or be offered, exposed or advertised to be, lent, hired, pledged, given away, exchanged, sold or otherwise disposed of in the United Kingdom and that they would be exported from the United Kingdom on the departure from the United Kingdom of the said Abdul Rahim, those conditions have not been complied with.

Whereby and by force of Article 17 (2) of the Customs Duty (Personal Reliefs) Order 1970 (as amended) and Section 257 of the Customs and Excise Act 1952 as amended, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in England who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
