NORTH YORKSHIRE COUNTY COUNCIL

The North Yorkshire County Council (Thornton Dale) (Prohibition of Waiting) Order 1978

Notice is hereby given that the Council of the County of North Yorkshire propose to make an Order under section 1(1), (2), and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act, 1974, the effect of which will be to prohibit the waiting of vehicles at any time on the following lengths of the Thirsk-Scarborough Class 1 County Road A.170 in the village of Thornton Dale:

- (a) *Cross Street*, south side, from its junction with Brock Lane (Unclassified County Road) for a distance of 25 metres in a westerly direction;
- (b) *Pickering Road*, north side, from a point 33 metres west of its junction with Whitby Gate (Marishes—Levisham Class III County Road C.67) for a distance of 71 metres in a westerly direction.

An exemption clause will permit the setting down and picking up of passengers, loading and unloading goods and other essential purposes.

NORTH YORKSHIRE COUNTY COUNCIL

The Council of the County of North Yorkshire (Pickering) (Prohibition of Waiting) Order 1978

Notice is hereby given that the Council of the County of North Yorkshire propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to prohibit the waiting of vehicles at any time on the eastern side of the new Malton—Whitby Class I County Road A.169 Kirkham Lane, Pickering, from a point 61 metres south of its junction with Ruffa Lane (Unclassified County Road) to a point 56 metres north of that junction.

An exemption clause will permit the setting down and picking up of passengers, loading and unloading goods and other essential purposes.

SOUTH YORKSHIRE COUNTY COUNCIL

(Parking Places and Controlled Parking Zone) (Doncaster) Order 1978

Notice is hereby given that on the 30th day of March 1978 the South Yorkshire County Council made an Order under Sections 1(1), (2) and (3), 31(1), 36, 37 and 39 of the Road Traffic Regulations Act 1967, as amended by part IX of the Transport Act 1968 and Schedule 19 of the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The general effect of the Order which will come into operation on the 10th day of April 1978 and which relates to roads in the Metropolitan District of Doncaster is:—

- (i) To authorise the use of each of the parts of road specified in column 4 of the Schedule to this notice as parking place.
- (ii) To prohibit waiting of vehicles between the hours of 8.00 a.m. and 6.00 p.m. on any day not being a Sunday, Christmas Day or a Bank Holiday other than a Good Friday in the parts of roads specified in column 2 of the Schedule to this notice.
- (iii) To prohibit the waiting of vehicles at any time in the parts of roads specified in column 3 of the Schedule to this notice.
- (iv) To prohibit vehicles waiting for the purposes of delivering or collecting goods or merchandise or loading between the hours of 8.00 a.m. and 9.30 a.m. and between the hours of 4.30 p.m. and 6.00 p.m. Monday to Saturday inclusive in the roads particularly specified in parts of East Laithe Gate and Market Road.
- (v) To prohibit waiting for the purposes of delivering or collecting goods or merchandise or loading and unloading at any time or any day in Waterdale.
- (vi) To prohibit the driving of vehicles in the roads or lengths of road specified in column 5 to this notice other than in the direction specified in the said column.
- (vii) To authorise the use of parts of Cleveland Street and Princegate as parking places for bicycles propelled by mechanical powers and not having a side car attached.

Exceptions have been provided in the Order insofar as it relates to the restriction and prohibition of waiting for the purposes of, inter alia, boarding or alighting, loading and unloading (except at any time in Waterdale), building and road works, maintenance of essential services and the delivery or collection of postal packets by vehicles in the service of the Post Office. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the Order and a map showing the road the subject of the Order may be examined during normal office hours at the offices of (i) the County Council, Brierley Hall, Brierley, near Barnsley and (ii) Doncaster Central Library, Waterdale, Doncaster, (iii) the County Council, Doncaster Area Consumer Advice Centre, 11 North Hall, Arndale Centre, Doncaster, (iv) the Doncaster Metropolitan Borough Council, Danum House, St. Sepulchre Gate, Doncaster.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, amended as aforesaid, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from the 30th March 1978 apply to the High Court for this purpose.
