NOTICE OF PUBLIC PATH ORDER

HIGHWAYS ACT 1959

COUNTRYSIDE ACT 1968

The Babergh District Council (Parish of East Bergholt (Footpaths Nos. 22 and 26) Public Path Diversion Order 1978.

Notice is hereby given that the above-named Order made on 28th March 1978, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Babergh District Council as an unopposed Order.

The effect of the Order if confirmed without modifications will be to (i) divert that part of footpath No. 22 East Bergholt running from a point opposite Willy Lott's Cottage in an easterly direction for 180 metres across field OS No. 0004, to a new route extending from beside Willy Lott's Cottage in a north-easterly direction for 200 metres along the boundary of the said field and thence in a generally southerly direction along the boundary of the said field for 98 metres to join the existing line of the footpath, (ii) divert that part of footpath No. 22 running from a point on the south-western corner of field OS No. 0048 approximately 280 metres east of Willy Lott's Cottage along the line of the hedge on the southern boundary in an easterly direction for 120 metres to a point at the stile on the south eastern corner of the said field, to a new route running from the same starting point in an easterly direction for 120 metres along the northern boundary of field OS No. 0004 thence across two bridges to join the existing line of the footpath at the said stile; (iii) divert that part of footpath No. 26 East Bergholt running from a point 110 metres east of Clapper Farm in a north-easterly direction for 50 metres to its junction with footpath No. 28; to a line extending in a northerly direction for 38 metres to the junction with footpath No. 27.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the offices of the District Secretary, Babergh D.C. Toppesfield Hall, Hadleigh, Ipswich, between 9 a.m. and 1 p.m. and 2 p.m. to 5 p.m. Mondays to Fridays.

Any representation or objection with respect to the Order may be sent in writing to the District Secretary, Babergh D.C. Toppesfield Hall, Hadleigh, Ipswich, before the 12th May 1978 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Babergh District Council may instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State, any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
