The County Council of Durham (Various Streets, Chester-le-Street) (Traffic Management) Order 1978

Notice is hereby given that on the 6th April 1978 the Durham Council made an Order under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Sched-ule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order, which will come into operation on 13th April 1978 is to prohibit and restrict traffic on roads at Chester-le-Street in Chester-le-Street District as follows:

 - Hadrian Avenue, both sides from its junction with Pick-tree Lane for a distance of 20 yards in a northerly direction.
- (ii) At any time including a ban on loading and unloading
 - Ropery Lane, southern side from its junction with Park Road South and Park Road Central to its junction with Front Street.
 - (iii) Between 8 a.m. and 6 p.m.
 - (a) Ropery Lane, northside from its junction with Queen's Park to a point 68 yards east of its junction with Front Street.
