

(19) divert the public footpath (Path No. 849) in the Parish of Harting, by stopping up the path commencing at its junction with the B.2146 road opposite New Barn, extending generally southwards for a distance of approximately 1,220 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at a point on the B.2146 road approximately 40 feet east of the northern end of the length of path proposed to be stopped up, extending southwards via a 14 foot gateway for a distance of approximately 260 feet on a western headland of pasture, thence south-westwards on a northern headland of pasture for a distance of approximately 100 feet, thence generally southwards on a western headland of pasture for a distance of approximately 880 feet, to rejoin the original route at the southern end of the length of path proposed to be stopped up.

(20) divert part of the public footpath (Path No. 861) in the Parish of Harting, by stopping up the path commencing at its junction with public footpath (Path No. 862) at a point approximately 700 feet north-west of Downpark, extending north-eastwards through Downpark Common for a distance of approximately 975 feet, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the north-eastern end of the length of path proposed to be stopped up, extending generally south-westwards curving southwards along an earthen land occupation track, for a distance of approximately 850 feet, to join the public footpath (Path No. 862) approximately 560 feet south-east of the south-western end of the length of path to be stopped up.

(21) extinguish the public footpath (Path No. 1159) in the Parish of Rogate, commencing at its junction with the A.3 road approximately 300 feet north-east of Hatch Lane, extending south-eastwards for a distance of approximately 520 feet to join the public footpath (Path No. 1156) at a point approximately 70 feet south of Holly Cottage.

(22) divert part of the public footpath (Path No. 1164/1) in the Parish of Rogate, by stopping up the path commencing at its junction with the maintainable highway north of Combe Pond, extending south-eastwards curving eastwards for a distance of approximately 610 feet, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the south-eastern end of the length of path proposed to be stopped up, extending north-eastwards for a distance of approximately 140 feet to join the maintainable highway at a point approximately 510 feet south-east of the north-western end of the length of path proposed to be stopped up.

(23) divert part of the public footpath (Path No. 1165) in the Parish of Rogate, by stopping up the path commencing at a point approximately 180 feet north-west of its junction with public footpath (Path No. 1164/1), and approximately 1,000 feet south-east of Goldring Farm, extending south-eastwards for a distance of approximately 1,940 feet to join the maintainable highway approximately 100 feet from the Parish boundary, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the north-western end of the length of path proposed to be stopped up, extending south-eastwards along a north-eastern headland for a distance of approximately 140 feet to join the public footpath (Path No. 1164/1), thence generally southwards to cross the original route along a western headland for a distance of approximately 870 feet (the northern 100 feet coincident with public footpath (Path No. 1164/1)), to join the maintainable highway at a point approximately 400 feet west of the point where public bridleway (Path No. 1164/2) joins the maintainable highway.

Copies of the Orders as confirmed and the maps contained in them have been deposited and may be inspected free of charge at the Office of the County Secretary, County Hall, Chichester, and at the Area Office of the Chichester District Council, Council Offices, Midhurst between 10 a.m. and 5 p.m. on Mondays to Fridays inclusive. Please note that the Area Office is closed between 1 p.m. and 2 p.m.

The Orders become operative as from 28th April 1978 but if a person aggrieved by the Orders desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act, 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made hereunder has not been complied with in relation to the Orders he may, under paragraph 2 of Schedule 2 to the

Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 7th April 1978, make an application for the purpose to the High Court.

#### WYCOMBE DISTRICT COUNCIL HIGHWAYS ACT 1959

*The Wycombe District Council (Footpath No. 75, Bartholomew Tipping County Secondary School, Parish of Stokenchurch) Public Path Diversion Order 1978.*

Notice is hereby given that the above-named Order, made on 20th March 1978, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by Wycombe District Council.

The effect of the Order if confirmed without modification, will be to divert the section of public footpath No. 75 at Bartholomew Tipping County Secondary School, Stokenchurch in the County of Buckingham commencing approximately 760 feet from the commencement of the footpath at the said school along the southern-most boundary of the school's playing fields, National Grid Reference 767961 and running in an arc in a north-easterly direction for a distance of approximately 350 feet to join the south-eastern boundary to the said playing field at National Grid Reference 768962 to a line from the aforementioned National Grid Reference 767961 for a distance of approximately 250 feet in an easterly direction following the boundary of the playing field to its southern-most point, National Grid Reference 768960, and then following the boundary north for a distance of approximately 287 feet to join the existing footpath at National Grid Reference 768962.

If no representations or objections are duly made, or if any so made are withdrawn, Wycombe District Council may, instead of submitting the Order to the Secretary of State for the Environment, itself confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

##### HIGHWAYS ACT 1959

*North Yorkshire County Council Footpath at Easingwold Diversion Order 1978*

Notice is hereby given that the above-named Order made on 2nd February 1978, is about to be submitted to the Secretary of State for the Department of the Environment for confirmation as an opposed Order or to be confirmed as an unopposed Order by the North Yorkshire County Council.

The effect of the Order if confirmed without modification will be to divert the public right of way commencing at point A from the Easingwold to Stillington Road (West Lane, Easingwold) approximately 66 yards from the North West corner of Easingwold Golf Course and running in a south-easterly direction through the Golf Course and its extension across fields O.S. 1104, 1094, 1103, 1102, 1101, 320 and 321 (O.S. Sheet County Series Edition of 1911 no. 121/16) for a distance of approximately 1350 yards to point C in the south-east corner of the Golf Course Extensions to commence at point D on the track immediately to the east of the Golf Club House and following generally the eastern and northern boundary of the Golf Course and its extension through OS Fields Nos. 1094, 1103, 1102, 1101, 320 and 321 to the south-east corner of the Golf Course (point C) for a distance of approximately 1500 yards.
