The District of North West Leicestershire (Brook Street (West), Ashby-de-la-Zouch) (High Street/Gladstone Street, Ibstock) (High Street, Measham) (Blackfordby Lane, Moira) (Silver Street, Whitwick) (Borough Street, Castle Donington) (Off-Street Parking Place) Orders 197.

Notice is hereby given that the North West Leicestershire District Council propose to make Orders under section 31(1), (2) and (4) of the Road Traffic Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Local Government Act 1974, to control the use of the parking places named in the Schedule to this Order which shows the class of vehicles, the days and times of operation, the maximum period for waiting and the scale of charges proposed for each parking place.

The Order will specify the conditions under which the parking places may be used. Full details are contained in the draft Orders which, together with maps showing the location of the parking places, may be inspected at the Council Offices, London Road, Coalville, between the hours of 9 a.m. and 5 p.m., on Mondays to Fridays.

If anyone wishes to object to these Orders, the objection, together with the grounds for making it should be made in writing to the undersigned not later than 28th April 1978.
