Rating of Unoccupied Properties

Notice is hereby given that the Liverpool Rating Authority at its meeting held on 29th March 1978, passed the following resolution:

(a) Minute No. 172 of this Committee of the 24th March 1976, relating to the rating of unoccupied property, be rescinded;

(b) With effect from the 1st April 1978, the provisions of section 17 and Schedule 1 of the General Rate Act 1967, as amended by the Local Government Act, 1974, shall apply to all unoccupied relevant hereditaments within the meaning of the 1967 Act, having a rateable value in excess of £50, with the exception of hereditaments newly constructed and not previously occupied, and that the specified proportion of unoccupied rate to be levied on those hereditaments be fixed at 100 per cent. of the rates chargeable, except that with regard to:

- (i) Dwelling-houses as defined in section 115 and Schedule 13 of the General Rate Act, 1967; and
- (ii) Mixed hereditaments as defined in section 48(5) of the General Rate Act, 1967;

the specified proportion of the amount payable shall be 100 per cent. of that chargeable in respect of:

- (i) Occupied dwelling-houses; or
- (ii) Occupied mixed hereditaments respectively.
