And the second petitioner Joseph Fox by his solicitors undertaking within one month of the restoration of the name of the company to the register to deliver to the Registrar of Companies as required by sections 1 and 6 of the Companies Act 1976 a copy of every document required by the said section 1 to be comprised in the accounts of the company

This Court doth order that the name of the above-named Carballoy Steel (Export) Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the Companies Act 1948 the said Carballoy Steel (Export) Limited is thereupon to be deemed to have continued in existence, as if its name had not been struck off
