

The Order contains the usual exemptions including the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to the restricted lengths of road.

In addition the Order will also contain the usual parking concession for disabled persons in accordance with the Orange Badge Scheme.

Full details of these proposals are contained in the draft Order, which, together with a map showing the streets affected and a map showing the Council's reasons for proposing to make the Order, may be examined at the offices of the Dyfed County Council at County Hall, Carmarthen and at the Area Surveyor's Office at High Street, Fishguard during the normal office hours.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to the undersigned by the 5th May 1978.

SCHEDULE 1

No waiting at any time

Lengths and sides of road to be made subject to a Prohibition of Waiting

1. *Heol Dyfed*, on both sides, from the junction with Windyhall for a distance of 15 metres.
2. *Heol Dewi*, on both sides, from the junction with Windyhall for a distance of 10 metres.
3. *Victoria Avenue*, on both sides, from the junction with Vergam Terrace for a distance of 10 metres.
4. *Clive Road*
 - (a) North-west side, from the junction with West Street for a distance of 114 metres.
 - (b) South-east side
 - (i) From the junction with West Street for a distance of 15 metres.
 - (ii) From its junction with the car park exit road for a distance of 10 metres in a north-easterly direction.
5. *Brodog Terrace*
 - (a) Westerly side, from its junction with West Street for a distance of 85 metres in a north-east and then north-westerly direction.
 - (b) Easterly side, from its junction with West Street for a distance of 15 metres in a north-westerly direction.
6. *Brodog Lane*, on both sides from its junction with West Street for a distance of 90 metres.
7. *Penlade*, on both sides, from its junction with West Street to its junction with Bryn Terrace.
8. *Ropeyard Lane*
 - (i) On the north-west side from its junction with West Street to the Car Park entrance.
 - (ii) On the south-east side from its junction with West Street to its junction with Penbanc.
9. *Lota Park Road*, from its junction with High Street for a distance of 10 metres.
10. *Hamilton Street*, on both sides from its junction with Main Street to its junction with Park Street.
11. *Wallis Street*, west side
 - (i) From its junction with Parcyshwt Car Park for a distance of 15 metres.
 - (ii) From a point 133 metres south of Parcyshwt Car Park entrance for a distance of 43 metres.
12. *Kensington Street*, on both sides from its junction with Main Street to its junction with Hottipass Street.

SCHEDULE 2

No Waiting, 8 a.m. to 8 p.m. on all days

Lengths and sides of road in which waiting is to be prohibited between 8 a.m. and 8 p.m. on all days

1. *Tower Hill*
North side
 - (i) From the junction with Hill Terrace for a distance of 8 metres in an easterly direction.
 - (ii) From a point 29 metres east of the junction with Hill Terrace for a distance of 15 metres in an easterly direction.

(iii) From a point 50 metres east of the junction with Hill Terrace for a distance of 126 metres in an easterly direction.

South side, from the junction with Hill Terrace for a distance of 100 metres.

SCHEDULE 3

No waiting 8 a.m.-6 p.m. on all days

Lengths and sides of road in which waiting is to be prohibited between 8 a.m. and 6 p.m. on all days

1. *Heol Dyfed*, north-west side, from a point 15 metres from Windyhall to the entrance to the Fishguard Comprehensive Secondary School.
2. *Clive Road*, south-east side, from a point 15 metres from junction with West Street to a point 10 metres from the car park exit.
3. *Wallis Street*, east side, from the junction with Park Street in a southerly direction for a distance of 167 metres.

SCHEDULE 4

No waiting 8 a.m.-6 p.m. Monday to Saturday, during the period 1st April to 30th September each year

Length and sides of road which is to be subject to a Seasonal prohibition of waiting

1. *Park Street*, on both sides, from the junction with Hamilton Street to the junction with Hottipass Street.

SCHEDULE 5

Limited waiting 1 hour in any 2 hours on any day 8 a.m.-8 p.m.

Length and sides of road to be made subject to Restricted Waiting

1. *Tower Hill*
 - (a) North side
 - (i) From a point 8 metres east of the junction with Hill Terrace for a distance of 21 metres in an easterly direction.
 - (ii) From a point 44 metres east of the junction with Hill Terrace for a distance of 6 metres in an easterly direction.
 - (b) South side, from a point 100 metres from its junction with Hill Terrace for a distance of 78 metres.

SCHEDULE 6

Limited waiting 20 minutes in any 1 hour Monday to Saturday 8 a.m.-6 p.m.

Side of road to be made subject to Restricted Waiting

1. *Brodog Terrace*, easterly side, from a point 15 metres north-east of its junction with West Street in a north-easterly direction to its junction with Brodog Road. (501)

West Glamorgan County Council (Resolven (Street Parking Places)) Order 1965 (Part Revocation) Order 1978

Notice is hereby given that on 10th April 1978 the West Glamorgan County Council made an Order in exercise of their powers under section 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 propose to make an Order the effect which is to revoke the Street Parking Places Order 1965 made by the Neath Rural District Council insofar as it relates to the south side of the unmade road fronting the length of the Ynysfach Junior and Infants School.

The Order will come into operation on 14th April 1978 and will be cited as the "West Glamorgan County Council (Resolven (Street Parking Places)) Order 1965 (Part Revocation) Order 1978."

If you wish to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date of this notice apply to the High Court for this purpose.
