Dominion Road, south-west side, from a point 25 metres (27.3 yards) north-west of the western kerbline of Angola Road north-westwards for a distance of 40 metres (43.7 vards).

Station Road, north side, from a point 71.5 metres (78.2 yards) east of a point in line with the eastern kerbline of Dagmar Street eastwards and southwards to a point 6 metres (6.6 yards) north of the northern kerbline of Chesswood Road.
