

compulsorily the land described below in connection with and for the purpose of construction of a primary distribution road between Croston Road and Emnie Lane, Leyland, Lancashire, proposals for which development were approved under section 6 (1) of the New Towns Act 1965 by the Secretary of State for the Environment on 29th March 1978.

2. A copy of the Order and of the accompanying map may be seen at all reasonable hours at the offices of the Corporation, Cuerden Hall, Bamber Bridge, Preston, PR5 6AX.

3. Any objection to the Order must be made in writing to the Secretary of State for the Environment, Becket House, Lambeth Palace Road, London, SE1 7ER before 15th May 1978 and should state the title of the Order and the grounds of objection.

4. The Secretary of State is not required in every case to arrange for a public local inquiry to be held or for objections to be heard by a person appointed by him for that purpose. It is important therefore, that any objection should include a full statement in writing of the grounds on which the objection is made, as the objector may have no further opportunity to make such a statement.

5. Any owner or occupier of any of the land to which the Order relates may (whether or not he makes an objection to the Order) send to the Corporation at Cuerden Hall, Bamber Bridge, Preston, PR5 6AX a request in writing that, in the event of the Order being confirmed by the Secretary of State, he be served with a notice stating that the Order has been confirmed and naming a place where a copy of the Order and of the map or maps and any descriptive material annexed thereto may be seen. Any such request must state the name and postal address of the owner or occupier making it, must state the nature of his interest in the land and must include sufficient particulars to enable the extent and boundaries of his land to be identified.

- 11W/19. 0.04 acres or thereabouts of highway part of Longmeanygate Leyland fronting to agricultural land lying to the east of the Farm Produce Warehouse, Longmeanygate and bounded on the north by highway land fronting to agricultural land part of "Greengables", Longmeanygate and on the east by other highway part of Longmeanygate and fronting 71 Longmeanygate.
- 11W/19A. 0.089 acres or thereabouts of highway part of Longmeanygate Leyland fronting to agricultural land lying to the east of 71 Longmeanygate bounded on the east by highway fronting 71 Longmeanygate on the north by highway lying to the east of highway fronting land at "Greengables", Longmeanygate and on the east by highway fronting land at Moss Farm, Longmeanygate.
- 11W/20. 0.05 acres or thereabouts of highway part of Longmeanygate Leyland fronting to 71 Longmeanygate bounded on the west by highway fronting to agricultural land lying to the east of the Farm Produce Warehouse, Longmeanygate on the north by highway fronting to land part of "Greengables", Longmeanygate and on the east by highway fronting agricultural land lying to the east of 71 Longmeanygate.
- 11W/23. 0.05 acres or thereabouts of highway part of Longmeanygate, Leyland fronting to agricultural land part of Moss Farm, Longmeanygate bounded on the west by highway fronting land lying to the east of 71 Longmeanygate on the north by highway lying to the east of highway fronting "Greengables" Longmeanygate and on the east by highway fronting other land part of Moss Farm, Longmeanygate.
- 11W/58. 0.10 acres or thereabouts of highway part of Dunkirk Lane, Leyland fronting to land part of 100 Dunkirk Lane bounded on the west by highway fronting the access track to "Lyngarth", Cocker Lane, Leyland in part and in part by land at 102 Dunkirk Lane on the south by highway fronting land at Dunkirk Hall, Dunkirk Lane and on the east by Dunkirk Bridge.
- 11W/59A. 0.013 acres or thereabouts of highway fronting in part land at 102 Dunkirk Lane, Leyland and in part the access track to "Lyngarth", Cocker Lane, Leyland bounded on the west by highway fronting the Nursery Dunkirk Lane on the south by highway fronting "Dunkirk Hall", Dunkirk Lane and on the east by highway fronting 100 Dunkirk Lane.
- 11W/62. 0.52 acres or thereabouts of waste land lying to the east of and being part of land at "Dunkirk Hall" Dunkirk Lane, Leyland and bounded on the north by Dunkirk Lane on the east and south by land to the west of the River Lostock between Dunkirk Bridge and Slater Lane Bridge.
- 11W/62A. 0.12 acres or thereabouts of highway fronting land at "Dunkirk Hall" Dunkirk Lane, Leyland bounded on the west by other highway fronting "Dunkirk Hall" on the north by highway fronting 102 Dunkirk Lane, the access track leading to "Lyngarth", Cocker Lane, Leyland and 100 Dunkirk Lane and on the east by Dunkirk Bridge.
- 11W/62B. 0.07 acres or thereabouts of highway fronting land between Slater Lane and the River Lostock bounded on the west by Slater Lane Bridge on the south by highway fronting land to the south of Slater Lane and east of the River Lostock and on the west by highway fronting land to the north of Slater Lane adjoining land at 74 Slater Lane.
- 11W/99. 0.07 acres or thereabouts of highway fronting 105 Slater Lane, Leyland bounded on the west by other highway fronting 105 Slater Lane on the north by highway lying to the west of Slater Lane Bridge and on the east by Slater Lane Bridge.
- 11W/104. 0.10 acres or thereabouts of land at the confluence of Mill Brook with the River Lostock and bounded on the south-west by Mill Brook and on the west by the River Lostock.
- 11W/104A. 0.08 acres or thereabouts of highway fronting land to the south of Slater Lane, Leyland bounded on the west by Slater Lane Bridge on the north in part by highway fronting land between Slater Lane Bridge and the River Lostock and in part by highway fronting land adjoining and to the west of 74 Slater Lane and on the east by highway fronting 59 Slater Lane.
- 11W/163. 0.19 acres or thereabouts of highway part of Emnie Lane, Leyland and fronting Firs Farm, Leyland Lane, Leyland bounded on the west by other highway part of Emnie Lane fronting Firs Farm on the south by other highway part of Emnie Lane fronting land at Little Firs Farm, Leyland Lane and on the east by Leyland Lane at the junction of Emnie Lane.
- 11W/164. 0.19 acres or thereabouts of highway part of Emnie Lane, Leyland fronting land at Little Firs Farm, Leyland Lane, Leyland bounded on the west by other highway part of Emnie Lane fronting Little Firs Farm on the north by highway part of Emnie Lane fronting land at Firs Farm, Leyland Lane and on the east by Leyland Lane at its junction with Emnie Lane.
- 11W/169. 0.95 acres or thereabouts of land to the rear of Downham Road, Leyland bounded on the north-west west and south by the centre of the River Lostock and on the east by land adjoining the properties 27/45 (odd numbers inclusive) Downham Road.
- 11W/171. 0.03 acres or thereabouts of access track and footpath at "Lyngarth" Dunkirk Lane, Leyland bounded on the north by Cocker Lane, Leyland on the east by land adjoining the River Lostock, on the south by the continuation of the footpath and access track to Dunkirk Lane and on the west by land and buildings known as "Lyngarth" Dunkirk Lane.
