PLANT HEALTH ACT 1967

Notice is hereby given that the Minister of Agriculture, Fisheries and Food has made the Progressive Wilt Disease of Hops Order 1978 (SI 1978 No. 505) under the Plant Health Act 1967.

This Order replaces the Progressive Wilt Disease of Hops Order 1955 and makes similar provision for the destruction of infected hop plants, the treatment or destruction of other infected things, and controls over cropping of land and the movement of hop plants, hop poles and other

The new Order prohibits the movement of hop plants into, within and from a specified area of Kent and Sussex.

The Order comes into operation on 28th April 1978.
