Notice is hereby given that an application is being made to the Anglian Water Authority, Essex River Division, by D. Gibson, Esq., Frowick Hall, St. Osyth, Essex, for a combined licence to obstruct or impede the flow of a ditch tributary of Flag Creek by means of a control weir at NGMR TM 119 182 and to abstract 5 million gallons of water per annum from the said inland water at or near that point, to fill a reservoir.

The capacity of the reservoir at overflow level will be 5 million gallons.

**NOTICE OF APPLICATION FOR A COMBINED LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN INLAND WATER BY MEANS OF IMPOUNDING WORKS AND TO ABSTRACT WATER.**

Notice is hereby given that an application is being made to the Southern Water Authority by E. F. Guthrie Limited for a combined licence to obstruct or impede the flow of a tributary of the River Teise by means of an earth dam at O.S. Map Reference TQ 667435, Paddock Wood, Tonbridge, Kent, and to abstract 7 million gallons of water per year from the said inland water at or near that point for spray irrigation including frost protection and trickle irrigation and the introduction of fish. The capacity of the reservoir at overflow level will be approximately 2 million gallons.

**DUDLEY METROPOLITAN BOROUGH  
CLEAN AIR ACT, 1956**

*The Borough of Dudley No. 136 (Coseley) Smoke Control Order 1978*

Notice is hereby given that the Borough Council of Dudley in exercise of the powers conferred on them by section 11 of the above-mentioned Act on the 14th April 1978, made the above Order declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (2) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels

include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st April 1979.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Council House, Dudley, at all reasonable times during the period of 6 weeks from the 21st April 1978.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Department of the Environment, 2 Marsham Street, London, SW1P 3EB, object to the confirmation of the Order.

**SCHEDULE**

The land at Coseley having an area of 212 acres or thereabouts bounded on the west by the centre line of Birmingham New Road to its junction with the Borough Boundary with Wolverhampton; on the north by the Borough Boundary with Wolverhampton from its junction with Birmingham New Road to its junction with the main railway line; on the east by the main railway line to a point abutting the northern boundary of the Tipton No. 1 Smoke Control Order 1963; and generally on the south by the northern boundary of the Tipton No. 1 Smoke Control Order, 1963 to its junction with the centre line of Birmingham New Road.

**COAST PROTECTION ACT, 1949**

Notice is hereby given that the Council of the Metropolitan Borough of North Tyneside acting in their capacity as Coast Protection Authority hereby give notice under subsection (1) of section 5 of the above Act, that they propose to carry out coast protection works as described herein to the cliffs between Briardene Burn to Curry's Point, Whitley Bay, in the said Borough.
