Side and Length of Road in the Borough of Taff-Ely

Taff Street, Pontypridd, on the western side, from a point 15 yards (13 metres) south of its junction with Mill Street southwards for a distance of 29 yards (27 metres). (496)

- (i) an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to revoke the existing provision contained in "The Urban District of Pontypridd (Various Streets) Traffic Regulation No. 1 Order 1968" prohibiting the waiting of vehicles between the hours of 7 a.m. and 7 p.m. on Monday to Saturday inclusive on the side of length of road described in the Schedule to this notice and
- (ii) an Order under sections 28 and 31 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972, the effect of which will be to designate the side of length of road described in the Schedule to this notice as a street parking place for disabled persons' vehicles displaying a disabled person's badge.

The Order comes into operation on the 23rd April 1978 and a copy thereof and a map showing the side of length of road to which the Order relates may be inspected at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff, during normal office hours until the end of 6 weeks from the 21st April 1978.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulations Act 1967, as amended, or on the grounds that any requirement of that Act as so amended or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks from the 21st April 1978, apply to the High Court for this purpose.

Taff Street, Pontypridd, on the western side, from a point 5 metres south of its south junction with Market Street southwards for a distance of 20 yards (18 metres). (498)

Mid Glamorgan County Council (Pontypridd—Central Area) (Experimental Traffic Regulation) Order No. 1 1978

Notice is hereby given that on the 13th April 1978, the Mid Glamorgan County Council made an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the

Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which is as follows:

1. To prohibit the waiting of vehicles on the following sides of lengths of roads for 24 hours per day, 7 days per week.

In the Town of Pontypridd in the Borough of Taff-Ely Broadway (Route A.4058)

North side, from a point opposite the northern boundary of the White Hart Public House eastwards for a distance of 575 yards (526m.).

South side, from the junction with High Street/Sardis Road eastwards for a distance of 140 yards (128m.).

South side, from a point 220 yards east of the junction with High Street and Sardis Road eastwards for a distance of 342 yards (313m.).

High Street

Both sides, from the junction with Broadway to the junction with Courthouse Street, a distance of approximately 173 yards (158m.).

Both sides, from its junction with Sardis Road and Broadway to a point 47 yards (43m.) in a northerly direction.

West side, from a point 47 yards (43m.) north of its junction with Sardis Road and Broadway to its junction with Taff Street, a distance of approximately 57 yards (52m.).

Sardis Road, both sides, from the junction with High Street and Broadway to the junction with Catherine Street and Rhondda Road, a distance of approximately 233 yards (212m.).

Mill Street (West), both sides, from its junction with Rhondda Road to the south-eastern boundary of No. 32 Mill Street, a distance of approximately 85 yards (78m.), to include the hammerhead at the western end.

Catherine Street, both sides, from its junction with Sardis Road and Rhondda Road to its junction with Church Street and Upper Church Street, a distance of approximately 87 yards (80m.).

Upper Church Street

South side, from its junction with Catherine Street and Gelliwastad Road for its entire length, a distance of approximately 80 yards (73m.) to include the cul de sac end.

North side, from its junction with Catherine Street and Gelliwastad Road for a distance of 15 yards (14m.).

Chapel Street, both sides, from its junction with Gelliwastad Road and Morgan Street westwards and northwards to its junction with the gyratory road of the bus station, a distance of approximately 108 yards (99m.).

Bridge Street, both sides, from its junction with Morgan Street to its junction with Sion Street, a distance of approximately 140 yards (127m.).

Berw Road, both sides, from its junction with Bridge Street northwards for a distance of 90 yards (82m.).

Taff Street

Both sides, from its junction with Bridge Street southwards for a distance of 15 yards (14m.).

West side, from its junction with Peniel Lane to the southern junction with Market Street, a distance of approximately 220 yards (201m.).

West side, from its junction with Mill Street to a point 15 yards (14m.) southwards.

Both sides, from a point 15 yards (14m.) north of its junction with Crossbrook Street to a point 15 yards (14m.) south of its junction with Crossbrook Street.

Market Street

West side, from its junction with Church Street to a point 15 yards (14m.) in a northerly direction.

West side, from its junction with Church Street to a point 15 yards (14 m.) in a southerly direction.

East side, from its northern junction with Taff Street to a point 20 yards (18m.) in a southerly direction.

West side, from its northern junction with Taff Street to a point 33 yards (30m.) in a southerly direction.

East side, from its southern junction with Taff Street to a point 27 yards (24m.) in a northerly direction.

Mill Street (East)

South side, from its junction with Taff Street to a point 57 yards (52m.) in a westerly direction.
