*(Various Streets, Sandfields Area, Swansea)
(Weight Restriction) (Amendment No. 1) Order 1978*

Notice is hereby given that on 19th April 1978, the West Glamorgan County Council made an Order under section 1 (1), (2), (3) and 84D(1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act, 1974, the effect of which will be to extend the 2 tons (unladen) weight restriction zone (6 p.m. to 8 a.m.) operative in the Sandfields Area of Swansea to include the following:

- (i) Commencing from the west side of the footbridge on the south side of Mumbles Road thereafter continuing eastwards along the south side of Oystermouth Road to its junction with the west side of Paxton Street.
- (ii) Recommencing on the south side of Oystermouth Road at its junction with the east side of Bathurst Street, thereafter continuing eastwards along the south side of Oystermouth Road to a point opposite the west side of Albert Row then across Oystermouth Road to the north side at its junction with Albert Row.

The Order will come into operation on 19th May 1978, and may be cited as "The West Glamorgan County Council (Various Streets, Sandfields Area, Swansea) (Weight Restriction) (Amendment No. 1) Order 1978.

HALTON BOROUGH COUNCIL

The Halton Borough Council (Busway) (No. 1) Order 1978

Notice is hereby given that the Halton Borough Council, as agents for the Cheshire County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which would be to prohibit any person from:

- (a) driving or causing or permitting to be driven any kind of vehicle, other than those detailed in the exemptions below, on any part of the road forming part of the Busway as shown by the blue line on the plan annexed to the Order, namely on that part of the Busway which extends from its junction with Aston Lane South for a distance of 360 metres in an easterly direction to a turning head at the A.533 Trunk Road at Whitehouse; and
- (b) using the said road as a foot passenger except in connection with the purposes of the exemptions to the Order and for the purpose of crossing the road at each of the two bus stops shown edged red on the plan annexed to the Order.

The Order would contain exemptions to permit the driving on the Busway by vehicles used as stage carriages and express carriages and vehicles used for emergency and maintenance purposes, for the removal of obstructions and in connection with the supply of gas, water, electricity, telegraphic lines and the transmission of radio and television.

A copy of the proposed Order and a map showing the length of road to which it relates, together with a statement of the Council's reasons for proposing to make the Order, may be inspected at the Municipal Building, Kingsway, Widnes; the Town Hall, Runcorn and the Information Centre, Church Street, Runcorn during normal office hours.

Any objections to the proposed Order, together with the grounds on which they are made, must be sent in writing to the undersigned by the 22nd May 1978.
