### SURREY COUNTY COUNCIL

#### ROAD TRAFFIC REGULATION ACT 1967 (AS AMENDED)

*The Surrey County Council (King's Road and Weydown Road, Haslemere) (Prohibition of Waiting) Order 1978*

Notice is hereby given that the Surrey County Council propose to make an order under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974. The effect of which will be to prohibit waiting in the following areas at the times stated in the first and second parts of the Schedule attached hereto.

The usual exemptions for loading and unloading vehicles boarding and alighting from vehicles, using vehicles for works on or adjoining those sides of road, the maintenance of the road and the services therein and for disabled persons' vehicles in accordance with the Orange Badge scheme will be included in the proposed Order.

A copy of the proposed Order together with a map showing the road to which the Order relates and a statement of the Council's reasons for proposing to make the Order may be examined free of charge at the County Deeds Office, (Room 119), County Hall, Kingston upon Thames (Mondays to Fridays 10 a.m. to 4 p.m.), The County Area Engineer's Office, Highway House, Onslow Street, Guildford, GU1 4SZ between the hours of 9 a.m. and 5 p.m. and at Godalming Branch Library, Bridge Street, Godalming, GU7 1HT between the hours of 10 a.m. and 7 p.m. Tuesdays, Thursdays and Fridays and between the hours of 10 a.m. and 5 p.m. on Wednesdays and between the hours of 9.30 a.m. and 1 p.m. on Saturdays.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to the undersigned by 19th May 1978 quoting reference BT/WAV TR.26/JAN.

- (iv) From a point 319 metres south-west of the junction with Lower Street south-westwards for a distance of 10 metres.
- (v) From a point 335 metres south-west of the junction with Lower Street south-westwards to the eastern boundary of Foundry Lane, a distance of 6 metres.
- (vi) From a point 349 metres (Western Boundary of Foundry Lane south-west of the junction with Lower Street south-westwards for a distance of 13 metres.
- (vii) From a point 369 metres south-west of the junction with Lower Street south-westwards for a distance of 5 metres.

*Weydown Road, west/north-west side, No waiting at any time*

- (i) From a point 39 metres north of the junction with B.2131, Wey Hill northwards for a distance of 14 metres.
- (ii) From a point 76 metres north of the junction with Wey Hill northwards for a distance of 15 metres.
- (iii) From a point 141 metres north/north-east of the junction with Wey Hill north-eastwards for a distance of 15 metres.

*Weydown Road, east/south-east side, No waiting at any time*

- (i) From a point north of the junction with B.2131, Wey Hill northwards for a distance of 37 metres.
- (ii) From a point 70 metres north of the junction with Wey Hill northwards for a distance of 7 metres.
- (iii) From a point 119 metres north/north-east of the junction with Wey Hill north-eastwards for a distance of 14 metres.
- (iv) From a point 160 metres north/north-east of the junction with Wey Hill north-eastwards for a distance of 13 metres.

*Derby Road, south-east side, No waiting at any time*

From a point 28 metres north-east of the junction with Weydown Road north-eastwards for a distance of 13 metres.

- (ii) From a point 134 metres south-west of the junction with Lower Street south-westwards for a distance of 18 metres.
- (iii) From a point 164 metres south-west of the junction with Lower Street south-westwards for a distance of 7 metres.
- (iv) From a point 177 metres south-west of the junction with Lower Street south-westwards for a distance of 17 metres.
- (v) From a point 201 metres south-west of the junction with Lower Street south-westwards for a distance of 19 metres.

- (iv) From a point 156 metres north-east of the junction with Wey Hill north-east/northwards for a distance of 96 metres.
