Notice is hereby given that the above-named Order, made on 18th April 1978, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed order, by the District Council of Uttlesford.

The effect of the Order, if confirmed without modifications, will be to extinguish the public right of way running from a point on the A.120 Braintree Road adjacent to the south-west corner of the property known as "Dormers" in a generally north-easterly direction for a distance of approximately 190 metres to its junction with Footpath 23, Great Dunmow.

*The Wiltshire County Council (Footpaths 11 and 12, Calne Without) Public Path Diversion Order 1978*

Notice is hereby given that on 18th April 1978, the Wiltshire County Council confirmed the above-named Order.

The effect of the Order as confirmed without modification is:

- (a) to extinguish the public rights over that length of Footpath No. 12, Calne Without, leading from its junction with Footpath No. 11 shortly due east of Berhills Farm in a westerly direction through the farm buildings; and to create an alternative right of way leading from the same point, north-westwards to the north of the farm buildings and then south-westwards to rejoin its original course to the west of the farm buildings; and
- (b) to extinguish the public rights over that length of Footpath No. 11, Calne Without, leading from its junction with Footpath No. 12 east of Berhills Farm, in a south-westerly direction to the disused Wilts and Berks Canal and over a bridge to the south bank; and to create an alternative right of way leading from the Calne town boundary at the end of Castle Walk southwards to a more easterly bridge over the disused Canal and then westwards along the southern bank to the first bridge.

A copy of the Order as confirmed and the map contained in it has been deposited at the Environment Division, County Solicitor and Clerk's Office, County Hall, Trowbridge, and may be inspected during normal office hours.

The Order becomes operative when the said County Council have certified that the alternative footpath has been provided, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any Regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under section 244 of the Town and Country Planning Act 1971, within 6 weeks from 27th April 1978, make application for the purpose to the High Court.

*The District of North Wiltshire (Footpaths Nos. 28 and 29 Seagry) Public Path Diversion Order 1977*

Notice is hereby given that on 13th February 1978, the North Wiltshire District Council confirmed the above-named Order.

The effect of the Order, as confirmed without modification, is to divert lengths of public rights of way known as Footpaths 28 and 29 in the parish of Seagry as described below:

"That length of Footpath No. 28 Seagry which runs from a point on the C.82 road in a westerly direction for approximately 630 yards to Seagry Wood shall be diverted to commence at a point approximately 70 yards south on the C.82 road and shall run westerly for approximately 250 yards, turning south for approximately 40 yards, turning west for approximately 90 yards, turning south for approximately 13 yards, turning west for approximately 265 yards and turning north for approximately 10 yards to Seagry Wood."

"That length of Footpath No. 29 Seagry which runs from a point on the C.166 road in a north-westerly direction for approximately 620 yards to Seagry Wood shall be diverted to commence at a point approximately 70 yards south-west on the C.166 road running north-west for approximately 157 yards, turning west for approximately 85 yards, turning north for approximately 80 yards and turning west for approximately 400 yards to Seagry Wood."
