#### **PASTORAL MEASURE 1968**

Notice is hereby given that Her Majesty was pleased on the 25th April 1978 by Order in Council to confirm the following Schemes made by the Church Commissioners for

- 1. Uniting the benefices and parishes of East and West Looe; and Saint Martin-by-Looe, in the diocese of Truro.
- 2. Uniting the benefices of Cam and Stinchcombe in the diocese of Gloucester.
- 3. Vesting part of the churchyard of the parish church of the parish of Tealby, in the diocese of Lincoln, in the Lincoln Diocesan Trust and Board of Finance Limited for disposal.
- 4. Providing the Redundant Churches Fund to be responsible for the care and maintenance of the redundant parish church of the former Parish of Blatherwycke, in the diocese of Peterborough.
- 5. Vesting part of the churchyard of the Parish Church of the parish of Saint Aidan, Bristol, in the diocese of Bristol, in the Bristol Diocesan Board of Finance Limited for disposal.
- 6. Uniting the benefices of Puddletown with Athelhampton and Burleston; and Tolpuddle, in the diocese of Salisbury.
- 7. Creating a new benefice and parish of Moulsham, Saint Luke, and altering the areas of the parishes of Saint John, Moulsham; Widford; Great Baddow; and Saint Michael, Calleywood Common, in the diocese of Chelmsford.
- 8. Appropriating the remains of the parish church of the parish of Colwick, in the diocese of Southwell, and the land annexed or belonging thereto, to use as a monument in connection with Colwick Country Park and for purposes ancillary thereto, and empowering the said Commissioners to give the said building and land for such uses.
- 9. Declaring redundant the church of All Saints, a chapel of ease in the parish of Nantwich, in the diocese of Chester, appropriating the redundant building to use by the parochial church council of the said parish for religious and other charitable purposes of the Church of England.
- 10. Uniting the benefices of Wymeswold; and Prestwold with Hoton, in the diocese of Leicester.
- 11. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant parish church of the former parish of Akenham, in the diocese of Saint Edmundsbury and Ipswich.
