 3. disabled persons' vehicles displaying a badge issued under the Local Authority's Orange Badge Scheme waiting for not more than 2 hours (no return within 1 hour);
 4. street cleansing vehicles.

ROAD TRAFFIC REGULATION ACT 1967

The County of Hereford and Worcester (College Road, Bromsgrove) (Restriction of Waiting) Order 1978

Notice is hereby given that the County Council of Hereford and Worcester propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers, the effect of which will be to prohibit the waiting of vehicles from Monday to Saturday 8 a.m. to 6.30 p.m. on:

- (a) the west side of College Road, Bromsgrove, from a point 27.4 metres (90 feet) from its junction with New Road to its junction with West Road; and,
- (b) 15 metres (49 feet) from the junction with West Road on the eastern side of College Road, Bromsgrove.

Waiting by vehicles of the under-mentioned classes or for the under-mentioned purposes are exempted from the provisions of the Order:

1. to enable persons to board or alight;
2. to enable goods to be loaded and unloaded;
3. vehicles in use by the Post Office;
4. to enable certain essential works to be carried out or in pursuance of statutory powers or duties;
5. for the collection or delivery of furniture or effects;
6. disabled persons' vehicles displaying a badge issued under the Local Authority's Orange Badge Scheme;
7. for fire brigade, ambulance and police purposes.

ROAD TRAFFIC REGULATION ACT 1967

Traffic Regulation Orders, Evesham

Notice is hereby given that the County Council of Hereford and Worcester propose to make the following Orders under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers:

1. The County of Hereford and Worcester (Pershore Road, School Road and Workman Road, Evesham) (Prohibition of Waiting) Order 1978.

2. The County of Hereford and Worcester (School Road and Workman Road, Evesham) (One-Way Traffic) Order 1978.

The effect of 1. above will be to:

- (i) prohibit waiting on the south side of Pershore Road from its junction with Peewit Road for a distance of 120 metres (393 feet) in a westerly direction.
- (ii) Prohibit waiting on the east side of School Road, from its junction with Pershore Road to its junction with Workman Road.

The Order will also revoke the waiting prohibition on the west side of Workman Road.

The effect of 2 above will be to:

- (i) make School Road, One-Way from north to south.
- (ii) make Workman Road, One-Way from south to north.

Exemptions in the Prohibition of Waiting Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of telegraphic lines;
- (f) the vehicle to taking in oil, petrol, water or air from any garage situate on the lengths of roads concerned;
- (g) any wedding or funeral at premises on the lengths of roads concerned;
- (h) the fire brigade, ambulance or police services.

An exemption in the Prohibition of Waiting Order also permits the waiting by disabled person's vehicles displaying a badge issued under the Local Authority's Orange Badge Scheme.

ROAD TRAFFIC REGULATION ACT 1967

Bromsgrove Western Inner Relief Road and Church Street, Bromsgrove Prohibition and Restriction of Waiting and One-Way Traffic Orders 1978.

Notice is hereby given that the County Council of Hereford and Worcester propose to make these Orders under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers, the effect of which will be to:

- (i) Prohibit waiting on both sides of the Bromsgrove Western Inner Relief from its junctions with St. John's Street to its junction with Church Street.
- (ii) Prohibit waiting on the south-western side of Church Street, Bromsgrove, from its junction with Bromsgrove Western Inner Relief Road for a distance of 15 metres (49 feet) in an easterly direction and for a distance of 15 metres (49 feet) in a westerly direction, (this will replace part of the existing waiting restrictions on Church Road).
- (iii) Make Church Street, Bromsgrove, one way from west to east from its junction with Crown Close to its junction with High Street.

Exceptions in (i) and (ii) above will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods;
