And upon hearing the solicitors for the applicants and for the Registrar of Companies (the Respondent)

And upon hearing the said application the affidavit of Margaret Wolley filed the seventh day of February 1978

And there being no opposition on behalf of The Crown to the relief sought by the said application

And both applicants by their solicitors undertaking within one month of the restoration of the name of the company to the register of companies: to forward to the Registrar of Companies as required by sections 124 and 126 of the Companies Act 1948 a copy of the annual return of the company for each of the years 1974, 1975 and 1977 to give to the Registrar of Companies as required by section 107 of the Companies Act 1948 a notice of any change in the situation of the registered office of the company.
