HIGHWAYS ACTS 1959 TO 1971

The Swansea-Manchester Trunk Road (Ammanford Road and Maidens Grove, Llandybie Improvement Side Roads) Order 1978.

The Secretary of State for Wales hereby gives notice that, in relation to the above-mentioned trunk road at Llandybie in the county of Dyfed, he has made under section 9 of the Highways Act 1959 an Order, the effect of which is-

(a) to authorise him-

(i) to improve, raise, lower or otherwise alter Amman-ford Road ;

(ii) to stop up Ammanford Road and Maidens Grove at their junction with the trunk road, all at Llandybie aforesaid.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff, CF4 5PL and at the offices of Dyfed County Council, County Hall, Carmarthen and at the Area Surveyor's Office, Dyfed County Council, Rhosmaen Street, Llandeilo, Dyfed, where they are open to inspection free of charge at all reasonable hours.
