- 13. Appropriating the redundant church of Saint Thomas, Eastville, in the diocese of Bristol, and the land annexed or belonging thereto to use for religious purposes and for purposes ancillary thereto by the New Testament Church of God and empowering the said Commissioners to sell the said building and land for such uses.
- 14. Uniting the benefices and parishes of All Saints, Islington; and Pentonville, in the diocese of London, and declaring redundant the parish church of the parish of Pentonville.
- 15. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant church of Saint James, Cooling, a former chapel of ease in the parish of Cliffe-at-Hoo with Cooling, in the diocese of Rochester, and the land annexed or belonging thereto.

The Trunk Road (Various Roads, Llanidloes) (Prohibition and Restriction of Waiting) Order 1978

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974 which will come into operation on 12th June 1978. The effect of the Order is:

1. to revoke the Trunk Road (Various Roads, Llanidloes) (Prohibition of Waiting) Order 1970;

to prohibit the waiting of any vehicle at any time on the sides of road specified in Schedules 1 and 2 of this Notice

3. to prohibit the waiting of any vehicle between the hours of 8.00 a.m. and 6 p.m. on any day other than a Sunday on the side of road specified in Schedule 3 to this Notice; and

4. to prohibit the waiting of any vehicle between the hous of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday for a longer period than 45 minutes in any 75 minutes on the sides of road specified in Schedule 4 to this Notice.

Exceptions are provided in the Order to enable a vehicle to wait on any of the sides of road specified in Schedules 2, 3 and 4 to this Notice for so long as may be necessary to enable a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building, industrial or demolition operation, the removal any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties.

Exceptions are also provided in the Order:

1. to enable a disabled person's vehicle which displays a disabled person's badge to wait on any of the sides of road specified in Schedule 4 to this Notice; and

2. to enable a disabled person's vehicle which displays both a disabled person's badge and a parking disc to wait on any of the sides of road specified in Schedules 2 and 3 to this Notice for a period not exceeding 2 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road).

A copy of the Order, together with a plan and Statement of Reasons for making the Order, may be seen during normal office hours at the offices of the Llanidloes Town Council, Town Hall, Llanidloes, during a period of 6 weeks from 22nd May 1978.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, or that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks of the 22nd May 1978 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
