(b) the hours during which the existing prohibition

applies:

(i) on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that such prohibition will apply:

(1) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of Elder Avenue specified in Schedule 2 to this notice;
(2) between 8 a.m. and 9.30 a.m. and between 4.30

p.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of Tottenham Lane specified

in Schedule 3 to this notice;
(ii) on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be changed so that such prohibition will apply between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of Elder Avenue specified in Schedule 2 to this notice;

(c) waiting by vehicles (otherwise than for the purpose of

delivering or collecting goods or loading or unloading a vehicle) will be prohibited:

(i) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 4 to this notice and in the first 18:29 metres of adjacent Harold Road, Harvey Road and Rokesly Avenue;

(ii) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of Tottenham Lane specified in Schedule 5 to this notice and in the first 18:29 metres of adjacent Inderwick Road, Montague Road and Nelson Road;

(d) waiting by vehicles for the purpose of delivering of collecting goods or loading or unloading a vehicle will be prohibited:

- (i) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of Tottenham Lane specified in Schedule 6 to this notice and in the length of Ferme Park Road specified in Schedule 4 to this notice :
- (ii) unless otherwise prohibited as above, for a period of more than 20 minutes in the same place between:
 - (1) 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets referred to in

sub-paragraph (c)(i) above;
(2) 4.30 p.m. and 6.30 p.m. on Mondays to
Saturdays inclusive in the lengths of streets referred
to in sub-paragraph (c)(ii) above;

(e) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (c) above will be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Haringey Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(f) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the lengths of streets referred to in sub-paragraph (c) above will be prohibited.

- 4. The prohibitions referred to in paragraph 3(c) and (d) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.
- 5. A copy of each of the Orders, which will come into operation on 17th July 1978, of the above-mentioned Order of 1972, and of the Haringey (Waiting and Loading Restriction) Order 1978 (and of the Order which has previously amended that Order) can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Orders were made in Room B.21, The County Hall, London, SEI 7PB.
- 6. Copies of each of the Orders may be purchased from the Information Centre, Greater London Council, The County Hall, London, SE1 7PB.
- 7. Any person desiring to question the validity of either of the Orders or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1967 or on the ground that any requirement of those sections of the Act or of section 84A, 84B or 84C of the Act or of any

regulations made under the said section 84C has not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.
