

3. *Woolton Road*, north side, from a point 47.5 metres east of the westerly curtilage of *Eldred Road*, to a point 13.7 metres east of its junction with *Towers Road*.
4. *Hattons Lane*, west side, from its junction with *Woolton Road*, northwards for a distance of 11.7 metres.
5. *Hattons Lane*, east side, from its junction with *Woolton Road*, to a point 12.7 metres north of its junction with *Irene Road*.
6. *Eldred Road*, west side, from its junction with *Woolton Road* to a point 12.7 metres north of its junction with *Irene Road*.
7. *Eldred Road*, east side, from its junction with *Woolton Road*, to a point 6.2 metres north of that junction.
8. *Eldred Road*, east side, from a point 13.7 metres south of its junction with *Irene Road*, to a point 12.7 metres north of that junction.
9. *Towers Road*, west side, from its junction with *Woolton Road*, for a distance of 6.2 metres.
10. *Towers Road*, west side, from a point 13.7 metres south of its junction with *Irene Road*, to a point 12.7 metres north of that junction.
11. *Towers Road*, east side, from its junction with *Woolton Road*, to a point 12.7 metres north of its junction with *Irene Road*.
12. *Irene Road*, both sides, from its junction with *Hattons Lane*, for a distance of 13.7 metres.
13. *Irene Road*, both sides, from a point 13.7 metres west of its junction with *Eldred Road*, to a point 13.7 metres east of that junction.
14. *Irene Road*, both sides, from a point 13.7 metres west of its junction with *Towers Road*, to a point 13.7 metres east of that junction. (497)

1. *Borough of Macclesfield (Station Road and Bulkeley Road Handforth) (Prohibition of Waiting) Order 1978*
2. *Borough of Macclesfield (Hall Road and Hawthorn Avenue Wilmslow) (Prohibition of Waiting) Order 1978*
3. *Borough of Macclesfield (Greenway Wilmslow) (Prohibition of Waiting) Order 1978*

5. *Borough of Macclesfield (Park Lane and Towers Road, Poynton) (Prohibition of Waiting) Order 1978*

Notice is hereby given that pursuant to arrangements made under section 101 of the Local Government Act 1972 with Cheshire County Council, the Macclesfield Borough Council propose to make Orders under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Orders will be as follows:

1. *Borough of Macclesfield (Station Road and Bulkeley Road, Handforth) (Prohibition of Waiting) Order 1978.*

To prohibit waiting at any time on:

Station Road, Handforth:

On the south side, from the junction with *Wilmslow Road* in an easterly direction to the junction with *Hall Road* (including the layby at *Handforth Station*).

On the north side, from the junction with *Wilmslow Road* in an easterly direction to the junction with *Hall Road*.

Bulkeley Road, both sides, from the junction of *Wilmslow Road* for a distance of 30 metres in a westerly direction.

In addition loading and unloading will be prohibited on the above lengths of road Monday to Friday (inclusive) between 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. and on Saturday between 8 a.m. and 9.30 a.m. and 11.30 a.m. and 1.30 p.m.

The *Wilmslow Urban District Council (Wilmslow Road, Bulkeley Road, Station Road, Handforth) (Prohibition of Waiting) Order (No. 2) 1970* as it affects the above roads will be revoked.

2. *Borough of Macclesfield (Hall Road and Hawthorn Avenue, Wilmslow) (Prohibition of Waiting) Order 1978.*

To prohibit waiting at any time on:

Hall Road, Handforth:

On the north-west side, from the junction with *Water Lane* for a distance of 10 metres in a north easterly direction and from the junction with *Hawthorn Avenue* for a distance of 10 metres in a south westerly direction.

On the south-east side, from the junction with *Water Lane* for a distance of 15 metres in a north westerly direction.

Hawthorn Avenue, Wilmslow, on both sides, for a distance of 10 metres in a north westerly direction from the junction with *Hall Road*.

3. *Borough of Macclesfield (Greenway, Wilmslow) (Prohibition of Waiting) Order 1978.*

To prohibit waiting between the hours of 8 a.m.—6.30 p.m. Monday to Saturday inclusive on *Greenway, Wilmslow* for its entire length from its junction with *Parkway*.

4. *Borough of Macclesfield (Approach Road, Wilmslow House, Wilmslow) (Prohibition of Waiting) Order 1978.*

To prohibit waiting between 8 a.m.—6.30 p.m. Monday to Saturday inclusive on both sides of the road at the rear of 28-12 *Water Lane, Wilmslow* for a distance of 50 metres.

5. *Borough of Macclesfield (Park Lane and Towers Road, Poynton) (Prohibition of Waiting) Order 1978.*

To prohibit waiting at any time on the northerly side of *Park Lane* in a westerly direction for a distance of 21 metres from its junction with *Towers Road* and on the southern side in a westerly direction from the south side of the junction with *Hockley Road* to a point 20 metres west of the junction with *Towers Road*. To prohibit waiting on both sides of *Towers Road* for a distance of 15 metres in a northerly direction from the junction with *Park Lane, Poynton*.

Exemptions in respect of the above Orders include the setting down and picking up of passengers, building, industrial or demolition operations, the supply of gas, water and electricity, the loading and unloading of goods (with certain exceptions in respect of Order No. 1) and in respect of disabled drivers vehicles.

Copies of the proposed Orders, statement of reasons and maps showing the lengths of road to which the Orders relate may be inspected during normal office hours at the Service Centre, Town Hall, Macclesfield. The documents in respect of Orders (1), (2), (3) and (4) may also be inspected at the Service Centre, Council Offices, Green Hall, Wilmslow. The documents in respect of Order No. 5 may also be inspected at the Service Centre, Park Lane, Poynton between 9 a.m. and 12.30 p.m. Monday to Friday.

Any objections to the proposals together with the grounds on which they are made should be sent in writing to the undersigned by 7th August 1978.

GREATER MANCHESTER COUNTY COUNCIL

The Greater Manchester County (Sillavan Way, Salford) (Restriction of Waiting) (County) Order 1977

Notice is hereby given that on 11th July 1978, the Greater Manchester County Council, made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit waiting between 8 a.m. and 6 p.m. on Mondays to Fridays on both sides of *Sillavan Way* for its entire length.

The Order contains exemptions to permit waiting for the purposes of boarding and alighting, loading or unloading, funerals, building operations or work on or under the length of road. In addition, disabled person's vehicles displaying a disabled person's badge, and a parking disc, will be able to wait for periods of up to two hours, return prohibited within one hour.

A copy of the Order which comes into operation on 14th July 1978, and the plan showing the road to which it relates, may be inspected between 9 a.m. and 4.30 p.m. on Mondays to Fridays at the County Secretary's Office, County Hall, (Minshull Street entrance), Piccadilly Gardens, Manchester, or the Common Law Section, Salford City Council, Albert Mill, 214 Chorley Road, Swinton.
