20. Uniting the benefices and parishes of North Harborne (otherwise known as Smethwick Holy Trinity) and Saint Alban, Smethwick, in the diocese of Birmingham.
21. Uniting the benefices and parishes of Saint Paul with Saint John, Masbrough; and Northfield, in the diocese of Sheffield, and declaring redundant the parish church of the parish of Northfield.
22. (1) Transferring the second turn of the patronage of the benefice of Moreton with Little Laver
(2) Transferring the parish of Little Laver from the benefice of Moreton with Little Laver to the benefice of High Laver and Magdalen Laver
(3) Altering the names of the benefices of Moreton with Little Laver; and High Laver and Magdalen Laver and
(4) Uniting the parishes of All Saints, High Laver, and Saint Mary Magdalen, Magdalen Laver, in the diocese of Chelmsford.
23. Uniting the benefices of Longworth and Hinton Waldrist; and Lyford with Charney, in the diocese of Oxford.

25. Uniting the benefices of Bath, Weston, All Saints; and North Stoke, in the diocese of Bath and Wells.
26. Uniting the benefices of Saint Luke, Sharlston; and Wragby, in the diocese of Wakefield.
27. Uniting the benefices of Saint John, Beckermest; and Saint Bridget, Beckermest with Ponsonby, in the diocese of Carlisle.
28. Uniting the parishes of Barkway; Reed; and Buckland, in the diocese of Saint Albans, and declaring redundant the parish church of the parish of Buckland.
29. (1) Appropriating part of the churchyard of the parish church of the parish of Bray and Braywood in the diocese of Oxford for any ecclesiastical purpose affecting the parish or any part thereof;
(2) vesting the said land in the Diocesan Trustees (Oxford) Limited and
(3) empowering the said trustees to dispose of the said land or any interest therein.
30. Uniting the benefices of Corringham with Springthorpe; Heapham; Willoughton; and Blyborough, in the diocese of Lincoln.
31. Creating a new benefice of Rydal, comprising the area of the parish of Rydal and altering the name of the benefice of Ambleside with Rydal and Brathay, in the diocese of Carlisle.

38. (1) Dissolving the benefice of Buckland Dinham with Elm, Orchardleigh and Lullington,
(2) creating the new benefice of Buckland Dinham;
(3) uniting the benefices of Mells with Vobster, Whatley and Chantry; and Kilmersdon with Babington,
(4) uniting the parishes of Kilmersdon and Babington,
- (5) transferring the parish of Elm to the new benefice at (3),
(6) uniting the benefices of Beckington with Standerwick; and Barkley with Rodden,

(8) uniting the benefices of Leigh-upon-Mendip and Stoke Saint Michael in the diocese of Bath and Wells.
39. Uniting the benefices and parishes of Frant; and Eridge Green, in the diocese of Chichester.
40. Uniting the benefices of Baltonsborough and Butleigh, in the diocese of Bath and Wells.
41. Uniting the benefices of Wellington; and Pipe and Lyde with Moreton-on-Lugg, in the diocese of Hereford.
42. Uniting the benefices and parishes of Saint Jude, South Shields; Holy Trinity, South Shields; Saint Francis, South Shields; and Jarrow Docks, in the diocese of Durham.
43. Uniting the benefices and parishes of the Chapel Royal, Brighton; and Saint Peter, Brighton, in the diocese of Chichester.
44. Uniting the benefices and parishes of Saint Martin, Birmingham; and Saint John and Saint Basil, Deritend, in the diocese of Birmingham.
45. Declaring redundant the Church of Saint Andrew, a chapel of ease in the parish of Bridport in the diocese of Salisbury.
46. Uniting the benefices and parishes of Christ Church and Saint Paul, Saint Marylebone; and Saint Mark with Saint Luke, Saint Marylebone, in the diocese of London, and establishing a team ministry for the area of the new benefice.
47. Establishing a team ministry for the area of the benefice of Ifield, in the diocese of Chichester.

55. Uniting the parishes of Arundel and Tortington and declaring redundant the parish church of the parish of Tortington, in the diocese of Chichester.
56. Uniting the benefices of Stanfordham and Maften, and effecting a transfer of patronage of the benefice of Felton, in the diocese of Newcastle.
57. Declaring redundant the parish church of the parish of Saint Matthias, Upper Tulse Hill, in the diocese of Southwark.
58. (1) Uniting the benefices of Blunham; and Tempsford with Little Barford
(2) Uniting the benefices of Cople and Willington
