The Conservation Area for Broughton concentrates around the three main streets of the village, Bridge Road, School Road and Causeway Road which converge around the Parish

Church to form the focal point of the village. Along Bridge Road the Conservation Area boundary commences where the road crosses Bury Brook, and includes all properties on the right-hand side of the road to its junction with Causeway Road. On the opposite side of the road Bridge Farm and Birds Farm are included within the boundary.

boundary. All properties along the Causeway Road to the North of Bury Brook come within the Conservation Area, which extends northwards along Bull Lane to include Manor Farm. To the south of the break, only White Hall Farm and its immediate surroundings are contained within the boundary. The Conservation Area boundary extends a short distance along School Road to include "The Old Rectory" and "Thatched Roof", but excludes the modern development immediately to the west of these properties. The boundary line runs northwards of Englefield Green House from the north-east corner of "Dolphins" along the rear boundaries of properties in "Hollycombe" crossing Coopers Hill Lane to include "The Mews", "The Barn" and "The Bungalow" continuing along the south-west boundary of the Shoreditch Teachers Training College, crossing Priest Hill to include "East Lodge", "North Lodge", "West Lodge" and "Corfield" thence southward crossing Bidgemeed Bood along the west boundary of "Silcrossing Ridgemead Road along the west boundary of "Sil-vester House" in a southerly direction to turn eastwards at the junction of Castle Hill Road and Bishopsgate Road, thence in a generally southerly direction through the curi-lage of "Castle Hill" to include the main house and lodge properties then in a south-east direction to join the north boundary of the existing Conservation Area at the northwest corner of the Green.
