20. 22. Uniting the benefices of Ilfracombe, Lee and West Down; Saint Sabinus, Woolacombe; and Bittadon, in the diocese of Exeter, and establishing a team ministry for the area of the new benefice.

23. Establishing a team ministry for the area of the benefice of Winlaton, in the diocese of Durham.

24. (1) Uniting the benefices of Saint Mary Magdalene, Bridgnorth; Bridgnorth, Saint Leonard with Tasley; Astley Abbotts; and Oldbury;

(2) uniting the parishes of Saint Mary Magdalene, Bridgnorth; and Bridgnorth, Saint Leonard; and

(3) establishing a team ministry for the area of the new benefice, in the diocese of Hereford.

30. (1) Dissolving the benefice and parish of Saint George, Sheffield;

(2) declaring redundant the parish church of the parish of Saint George, Sheffield; and

(3) altering the areas of the parishes of Saint George, Sheffield; Saint Mark, Broomhall; Gillcar (also known as "Saint Silas, Gillcar"; or "Saint Silas, Sheffield"); and Saint Matthew, Sheffield, in the diocese of Sheffield.

31. Vesting the churchyard of the former church of Saint Michael, Netherton, in the parish of Facombe, in the diocese of Winchester, in the Winchester Diocesan Board of Finance for disposal.
