*The South Kesteven District Council No. 10
(Grantham No. 26) Smoke Control Order 1978*

Notice is hereby given that the South Kesteven District Council in exercise of powers conferred on them by Section

11 of the above-mentioned Act on 4th May 1978 made an Order entitled The South Kesteven District Council No. 10 (Grantham No. 26) Smoke Control Order 1978, declaring the area described in the Schedule below to be a Smoke Control Area, which Order has been submitted to the Secretary of State for the Environment for confirmation.

By virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building will be guilty of an offence and liable to a fine not exceeding £100, unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

The Order will come into operation on 1st November 1979.
