The Sunderland (No. 18) Smoke Control Order 1978

1. Notice is hereby given that the Sunderland Borough Council in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the Twenty-Seventh day of September 1978 made an Order entitled "The Sunderland (No. 18) Smoke Control Order, 1978" declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the limitations and exemptions provided by the Order and by virtue of Section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding one hundred pounds unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.
3. If confirmed the Order will not come into operation before the First day of August 1979, or before a later date determined by the Secretary of State for the Environment.

The West Yorkshire Metropolitan County Council
(Bradford) (Traffic Regulation) (No. 15) Order 1978

Notice is hereby given that the West Yorkshire Metropolitan County Council have made the above Order under their powers in the Road Traffic Regulation Act 1967, as amended. (Prohibition and Restriction of Waiting) Order 1967*

Notice is hereby given that the County Council of Avon propose to make an Order under Sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to revoke the items relating to Bathurst Parade, Cumberland Road and Wapping Road in the City and County of Bristol (Prince Street and Wapping Road) (Traffic Regulation) (BG) Order 1969, the County Council of Avon (General Hospital Area, Bristol) (Consolidation of Waiting Restrictions) Order 1975 and to re-enact and impose the following waiting restrictions:

1. to prohibit any vehicle waiting at any time in the lengths and sides of road specified in Schedule 1 to this Notice;
2. to prohibit any vehicle waiting between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays (inclusive) in the lengths and sides of road specified in Schedule 2 to this Notice;
3. to restrict any vehicle waiting between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays (inclusive) for a longer period than one hour in any two hourly period in the lengths and sides of roads specified in Schedule 3 to this Notice.

Exemptions in the Order permit a vehicle to wait for the purpose of boarding or alighting; goods to be loaded or unloaded; Post Office services; maintenance of the road; supply of gas, water or electricity; pursuance of statutory powers or duties; taking in petrol, oil, water or air from any garage; weddings or funerals; police, fire brigade or ambulance services and in accordance with the current provisions for disabled persons' vehicles.
