Exceptions will be provided in the Order to enable vehicles, as described in 1 and 2 above, to proceed in the lengths of road referred to, if the vehicle is (a) being used for the conveyance of persons, goods or merchandise to or from any premises situated in that length of road; (b) being used for the purpose of agriculture or the conveyance of timber felled upon land adjacent to that length of road; (c) being used in connection with building operations or the repair of the roads or the services therein; (d) being used in an emergency for fire brigade, police or ambulance purposes; (e) to be garaged, serviced or repaired at any premises situated in that length of road; (f) being used by a Local Authority in pursuance of statutory powers or duties; (g) being used for the conveyance of goods for sale from the vehicle; and (h) a public service vehicle being used as a stage carriage, a scheduled express carriage, a school bus or a works bus.
