THE IMPORTED FOOD REGULATIONS 1968,  
AS AMENDED

*Singapore: Official Certificate*

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly give notice that in exercise of the powers conferred on them by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973 (S.I. 1973 No. 1351), and the Transfer of Functions (Wales) (No. 1) Order 1978 (S.I. 1978 No. 272) they hereby restrict recognition of the Official Certificate reproduced in the Schedule to the notice published in the *London Gazette* dated 17th November 1972 for the importation of meat products from Singapore, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 23rd November 1976 is hereby revoked.
