#### HEREFORD AND WORCESTER COUNTY COUNCIL

##### ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (Trinity Road, Malvern) (One-Way Traffic) (Variation) Order 1979*

Notice is hereby given that on 26th January 1979 the County Council of Hereford and Worcester made an Order under sections 1 (1), (2) and (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers the effect of which will be to cause any vehicle proceeding in the length of Trinity Road, Malvern which extends from a point 32 metres (105 feet) south-west of its junction with Hornyold Road to its junction with Cowligh Road, a distance of 122 metres (400 feet) to travel only in a westerly direction.

The Order will come into operation on 7th February 1979.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, between 9.30 a.m.-12.30 p.m. and 2 p.m.-4 p.m. from Monday to Friday inclusive.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of section 84A, 84B or 84C of the Act of 1967 or of any regulations made under the said section 84C has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

#### LANCASHIRE COUNTY COUNCIL

*The Lancashire County Council (Berry Lane, Longridge, Ribble Valley Borough) (Prohibition of Waiting) (Revocation) (Amendment) Order 1979*

Notice is hereby given that the Lancashire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

- (1) To revoke the Lancashire County Council (Various Streets, Longridge) (Restriction of Waiting) (Revocation) Order 1973 only insofar as it relates to that length of the south-west side of Berry Lane from its junction with Barclay Road for a distance of 55 metres (60 yards) in a south-easterly direction.
- (2) To prohibit the waiting of vehicles at all times on the length of road specified in the Schedule to this notice.

The Order will contain exemptions to allow vehicles to wait for as long as may be necessary to enable goods to be loaded or unloaded; to enable persons to board or alight or to enable it to be used in connection with any building

operation or demolition and the maintenance of essential services.

*The Lancashire County Council (Mossy Lea Road, Wrightington, West Lancashire District) (Prohibition and Restriction of Waiting) (Revocation) (Amendment) Order, 1979.*

Notice is hereby given that the Lancashire County Council have made the above Order under section 1 of the Road Traffic Regulation Act, 1967, as amended, the effects of which will be:

- (1) To revoke the Lancashire County Council (Mossy Lea Road, Wrightington, West Lancashire District) (Prohibition of Waiting) Order 1976.
- (2) To limit the waiting of vehicles on any day for a period of 30 minutes, return prohibited within thirty minutes, between the hours of 8 a.m. and 6 p.m. as specified in the First Schedule to this Notice.
- (3) To prohibit the waiting of vehicles at any time on the lengths of road specified in the Second Schedule to this Notice.

The Order contains exemptions to allow vehicles to wait for as long as may be necessary; to enable goods to be loaded or unloaded; to enable persons to board or alight, or to enable it to be used in connection with any building operation or demolition and the maintenance of essential services.

The Order comes into effect on 7th February 1979.

##### FIRST SCHEDULE

###### *Lengths of road at Wrightington in the West Lancashire District*

(a) The west side of Mossy Lea Road, from a point directly opposite the south side of the southernmost junction with Broadhurst Lane, in a southerly direction for a distance of 45 metres (49.2 lin. yds).

(b) The east side of Mossy Lea Road, from a point 145 metres (158.6 lin. yds.) north of the centre line of Hinds Head Avenue to a point 163 metres (178.3 lin. yds.) north of Hinds Head Avenue.

##### SECOND SCHEDULE

###### *Lengths of road at Wrightington in the West Lancashire District*

(a) The west side of Mossy Lea Road from the northerly side of the entrance to the Hinds Head Hotel car park in a northerly direction to a point 45 metres (49 lin. yds.) south of a point directly opposite the south side of the southernmost junction with Broadhurst Lane.
