Notice is hereby given, that pursuant to arrangements made under section 101 of the Local Government Act 1972 with Cheshire County Council the Macclesfield Borough Council propose to make Orders in accordance with the Road Traffic Regulation Act 1967 as amended.

The effect of the Orders will be as follows:

- (1) *Borough of Macclesfield (Anderson Street, Macclesfield) (Prohibition of Waiting) Order:*

To prohibit waiting on the east side of Anderson Street, Macclesfield from its junction with Longacre Street to its junction with Chester Road between the hours of 8.30 a.m. and 6 p.m.

- (2) *Borough of Macclesfield (Church Road, Wilmslow) (Prohibition of Waiting) Order:*

To prohibit waiting at all times on both sides of Church Road, Wilmslow for a distance of 10 metres in a south-easterly direction from its junction with Knutsford Road.

- (3) *Borough of Macclesfield (Clowes Street, Macclesfield) (Prohibition of Through Traffic) Order:*

To prohibit through traffic from using Clowes Street, Macclesfield. It is intended that the road be closed at its junction with Frances Street.

Exemptions in respect of Orders Nos. (1) and (2) will include in respect of the loading and unloading of goods, the supply of gas, water, electricity and disabled drivers' vehicles.

Copies of the proposed Orders, statements of reasons and maps showing the lengths of road to which the Orders relate may be inspected during normal office hours at the

- (1) *The Borough of Macclesfield (Access Roads A.34, Wilmslow) (Prohibition of Driving) Order 1979*
- (2) *The Borough of Macclesfield (Vicarage Lane/Lower Park Road/Glastonbury Drive, Poynton) (Prohibition of Through Traffic) Order 1979.*

Notice is hereby given that, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Cheshire County Council, the Borough Council on 22nd January 1979, made the above Orders in accordance with the Road Traffic Regulation Act 1967 as amended.

The effect of the Orders will be as follows:

- (1) *The Borough of Macclesfield (Access Roads A.34, Wilmslow) (Prohibition of Driving) Order 1979.*

To prohibit the use of the two access roads between the A.34 and the service road adjacent to the A.34/A.538 junction Wilmslow at all times by vehicles.

The Order becomes operative on 5th February 1979.

- (2) *The Borough of Macclesfield (Vicarage Lane/Lower Park Road/Glastonbury Drive, Poynton) (Prohibition of Through Traffic) Order 1979.*

To prohibit through traffic from proceeding from Lower Park Road to Vicarage Lane Poynton, from Vicarage Lane to Lower Park Road, Poynton and from Glastonbury Drive to Vicarage Lane and from Vicarage Lane to Glastonbury Drive at all times.

The Order becomes operative on 5th February 1979.
