

The effect of these Orders which will come into operation on 5th February 1979 will be as follows:

- (1) To establish "No Waiting at any time" on both sides of Priory Road (south of St. Denys Road) from the northern boundary wall of No. 183, Priory Road southwards to the southern boundary wall of No. 169, Priory Road.
- (2) To prohibit vehicles travelling in a north-easterly direction from making right hand turns into St. Denys Road from either Stanley Road or Adelaide Road.

Copies of the Orders, together with a plan showing the effect of the Orders may be inspected in Room 18 of my office during normal working hours.

If you wish to question the validity of these Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any of the requirements of that Act or of any instrument made under it has not been complied with in relation to the Orders you may, within 6 weeks from 29th January 1979 apply to the High Court for this purpose.

SOUTHEND-ON-SEA COUNTY BOROUGH COUNCIL

The County Borough of Southend-on-Sea Prohibition of Cycling Orders 1977

Notice is hereby given that on 1st February 1979 the Southend-on-Sea County Borough Council made Orders under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

The Order will come into operation on 2nd February 1979 and will prohibit the riding of any bicycle or tricycle on the underpass, subways and associated footways:

- (1) *Queensway*. Underpass, Subways and associated footways.
- (2) *Elm Road/Hermes Road*.—Subways and footways.
- (3) *Eagle Way/Constable Way*. Subways and footways.
- (4) *Hampton Gardens to Prince Avenue*. Footpath.
- (5) *Prittlewell Path*.—Footpath.

Copies of the Orders and maps showing the footpaths affected are available at the Civic Centre, Victoria Avenue, Southend-on-Sea where they may be examined between 8.30 a.m. and 5.30 p.m. Mondays to Fridays.

If you wish to question the validity of the Orders or any provision contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Orders, you may within 6 weeks from 1st February 1979 apply to the High Court for this purpose.

STEVENAGE BOROUGH COUNCIL

The Borough of Stevenage (Prohibition of Waiting) (Dovedale) Order 1979

Notice is hereby given that the Stevenage Borough Council acting under arrangements made with the Hertfordshire County Council pursuant to section 101 of the Local Government Act 1972 is proposing to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 the effect of which will be to prohibit waiting at all times on both sides of the length of Dovedale which runs in an easterly direction for a distance of 25 metres from its junction with Shephall Way.

Exemptions will permit, where necessary, vehicles to wait along the lengths

- (a) to enable persons to board or alight and goods to be loaded and unloaded therefrom;

- (b) when being used in connection with the maintenance of roads, building operations, the removal of obstructions to traffic, the laying, erection or repair of any sewer, main pipe or apparatus for the supply of gas, water, electricity, telegraphic line or television or radio broadcasting system or for fire brigade, ambulance or police purposes;
- (c) when displaying a disabled person's badge and disc.

Full details of the proposal are in the draft Order which, together with a map showing the length of road affected, and a statement of the Council's reasons for proposing to make the Order, may be examined at the Director of Administration and Legal Services' Department, 4th Floor, Southgate House, Southgate, Stevenage, during normal office hours.

SUFFOLK COUNTY COUNCIL

Suffolk County Council (Exeter Road, Newmarket) (Pro- hibition of Driving) Order 1979

Notice is hereby given that on 23rd January 1979 Suffolk County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit all motor vehicles from proceeding in the length of road specified in the Schedule to this notice unless the vehicle is being used:
