

NORTH YORKSHIRE COUNTY COUNCIL

The Council of the County of North Yorkshire (Cargate Hill and John Street, Filey) (One-Way Traffic) Order 1979.

Notice is hereby given that on 29th January 1979 the Council of the county of North Yorkshire made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit the driving of vehicles along:

- (a) Cargate Hill, Filey (Unclassified County Road) from its junction with John Street to its junction with Fore-shore Road in other than an easterly direction, and
- (b) John Street, Filey (Unclassified County Road) from its junction with Belle Vue Street to its junction with Cargate Hill in other than a southerly direction.

A copy of the Order which comes into operation on 7th February 1979 together with a map showing the roads affected may be examined at County Hall, Northallerton and the Police Station, Murray Street, Filey, during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 29th January 1979 apply to the High Court for this purpose.

SOUTH YORKSHIRE COUNTY COUNCIL

The South Yorkshire County Council (Unmade Access Road between Briggs Street and Wood Lane, Carlton) (Prohibition of Driving) Order 1979.

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to prohibit vehicles from proceeding in that length of the unmade access road which runs between Briggs Street and Wood Lane, Carlton from a point 26 metres south-west of its junction with Wood Lane, for a distance of 5 metres in a south-westerly direction.

A copy of the proposed Order together with a map showing the restricted roads and a statement of the County Council's reasons for proposing to make the Order may be examined during normal office hours at the offices of (i) the County Council, County Hall, Barnsley and (ii) Central Library, Shambles Street, Barnsley.

SOUTH YORKSHIRE COUNTY COUNCIL

The South Yorkshire County Council (Huddersfield Road, Darton) (Restriction of Waiting) Order 1979

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to restrict waiting by vehicles, at any time, to a period of one hour, return prohibited within three hours, in the side of road, as specified in the Schedule to this notice.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for

the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the proposed Order together with a map showing the restricted road and a statement of the County Council's reasons for proposing to make the Order may be examined during normal office hours at the offices of (i) the County Council, County Hall, Barnsley and (ii) Darton Branch Library, Council Offices, Darton, near Barnsley.

The South Yorkshire County Council (Footpath between Park Road and Thurnscoe Park, Thurnscoe) (Prohibition of Cycling) Order 1979.

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to prohibit any pedal bicycle or tricycle from being ridden on that length of footpath which extends from Park Road in a south-easterly direction along the southern side of Dearne Lea Old People's Home to the access to Thurnscoe Park at Thurnscoe, in the Barnsley Metropolitan District.

WEST YORKSHIRE COUNTY COUNCIL

The West Yorkshire Metropolitan County Council (Wakefield) (Traffic Regulation) (No. 21) Order 1977

Notice is hereby given that the West Yorkshire Metropolitan County Council have made the above Order under their powers in the Road Traffic Regulation Act 1967 as amended, which comes into force on 5th February 1979.

The effect of the Order which relates to roads at Wakefield is:

- (a) to prohibit waiting by vehicles at any time and to prohibit loading and unloading activities between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6 p.m. Mondays to Fridays in lengths of Westgate, Ings Road, Quebec Street and Piccadilly in the vicinity of their junctions.
- (b) to limit waiting to 1 hour in any period of 2 hours from 8 a.m. to 6 p.m. Mondays to Saturdays in Westgate (south side) from City Road to 5 metres east of Ings Road.
- (c) to limit waiting to 30 minutes in any period of 1 hour from 8 a.m. to 6 p.m. Mondays to Saturdays in the recently constructed lay by on Westgate (north side).

The Order contains exemptions for vehicles being used in connection with a wedding or funeral or in pursuance of statutory powers or duties, and for emergency services vehicles. There are also exemptions to the restrictions in (a) for vehicles loading and unloading goods to wait for up to 30 minutes except when the peak period loading ban is in force. The usual exemptions will apply for disabled persons vehicles.
